#### ORDER

By this Order, the commission grants MAUI ELECTRIC COMPANY, LIMITED's ("MECO") request to withdraw its application, filed on December 26, 2007.

I.

## Background

On October 1, 2007, MECO filed an application for commission approval of its budget for incremental 2008 integrated resource plan ("IRP") planning costs, and the subsequent recovery of those costs through its IRP Cost Recovery Provision ("Application").1

By Order No. 23788, filed on October 30, 2007, the commission directed the Parties to file a stipulated procedural schedule, incorporating their agreed-upon schedule with respect to this proceeding, within sixty (60) days from the date of the

MECO and the DIVISION OF CONSUMER ADVOCACY, DEPARTMENT OF COMMERCE AND CONSUMER AFFAIRS ("Consumer Advocate") are collectively referred to as the "Parties." No parties have moved to intervene or participate in this proceeding, pursuant to Hawaii Administrative Rules §§ 6-61-55, 6-61-56 and 6-61-57.

Order. In the alternative, if the Parties were unable to stipulate to such a schedule, they were to each submit a proposed procedural schedule for the commission's consideration within sixty (60) days from the date of the Order.

By letter dated November 1, 2007, MECO requested that the commission suspend the docket, pending the issuance of an interim decision and order in Docket No. 2006-0387, MECO's 2007 test year rate case. MECO also requested that the commission stay Order No. 23788. According to MECO, in Docket No. 2006-0387, MECO and the Consumer Advocate proposed to include a normalized level of IRP planning costs in base rates, which, if approved by the commission, would result in MECO terminating recovery of its IRP planning costs through its IRP Cost Recovery Provision, and withdrawal of its Application in this docket.

By Order No. 23828, filed on November 13, 2007, the commission approved MECO's request and suspended this docket until further order of the commission.

II.

#### Withdrawal of the Application

By letter dated and filed on December 26, 2007, MECO requests to withdraw its Application. According to MECO, by Interim Decision and Order No. 23926, filed on December 21, 2007, in Docket No. 2006-0387, the commission approved on an interim basis the inclusion of a normalized level of IRP planning costs

in MECO's test year revenue requirement and the recovery of those costs through an interim surcharge.

Based on the foregoing, the commission approves MECO's withdrawal of its Application without prejudice, and closes this docket.

#### THE COMMISSION ORDERS:

- MECO's request to withdraw its Application, filed on December 26, 2007, is granted.
- This docket is closed unless ordered otherwise by the commission.
