#### DECISION AND ORDER

By this Decision and Order, the commission adopts Proposed Decision and Order No. 23916, filed on December 20, 2007, as its Decision and Order in this proceeding. In addition, the commission finds that the revised tariff sheets and rate schedules filed by NORTH SHORE WASTEWATER TREATMENT, L.L.C. ("NSW") on January 17, 2008, comply with the Proposed Decision and Order. NSW's revised tariff sheets and rate schedules shall take effect immediately from the date of this Decision and Order.

## **Discussion**

#### Α.

## Proposed Decision and Order No. 23916

On December 20, 2007, the commission timely issued Proposed Decision and Order No. 23916, as mandated by Hawaii Revised Statutes ("HRS") § 269-16(f), and in response to the application filed by NSW on June 22, 2007.<sup>1</sup>

Proposed Decision and Order 23916. In No. the commission approved rates for NSW, as agreed upon by NSW and the COMMERCE CONSUMER DEPARTMENT OF AND AFFAIRS, DIVISION OF CONSUMER ADVOCACY ("Consumer Advocate")<sup>2</sup> (jointly, the "Parties") their "Stipulation of Settlement Agreement in Lieu in of Rebuttal Testimonies, jointly filed by the Parties on November 15,  $2007.^3$ 

Specifically, the commission approved, based on a 2007 calendar test year ("Test Year"):<sup>4</sup> a \$664,515<sup>5</sup> increase in NSW's revenues, resulting in a revenue requirement for NSW of \$686,595; an average Test Year rate base of \$863,790; and a return on rate base of 8.85%. In addition, the commission approved NSW's request to establish an Automatic Power Cost

Adjustment Clause that will allow NSW to increase or decrease its rates based on any corresponding increase or decrease in NSW's cost for electricity.

# The Parties' Acceptance of the Proposed Decision and Order

On December 24, 2007, the Consumer Advocate accepted <u>in toto</u> Proposed Decision and Order No. 23916.<sup>6</sup> By letter filed on December 31, 2007, NSW, likewise, accepted Proposed Decision and Order No. 23916.<sup>7</sup>

# Adoption of Proposed Decision and Order No. 23916

The Parties have accepted Proposed Decision and Order No. 23916. Accordingly, the Parties are not entitled to a contested case hearing, and HRS § 269-15.5 does not apply.<sup>8</sup> <u>See</u> HRS § 269-16(f)(3). In light of the foregoing, the commission adopts <u>in toto</u> Proposed Decision and Order No. 23916.

#### D.

## Revised Tariff Sheets and Rate Schedules

schedules, which implement the tariff changes and increases in rates and charges authorized by Proposed Decision and Order No. 23916, for the commission's review and approval.

On January 17, 2008, NSW filed its revised tariff sheets and rate schedules. The commission has reviewed NSW's revised tariff sheets and rate schedules, and finds that they are in compliance with Proposed Decision and Order No. 23916.<sup>9</sup> The commission accordingly approves NSW's revised tariff sheets and rate schedules, which shall become effective immediately as of the date of this Decision and Order. NSW is instructed to promptly re-file its revised tariff sheets and rate schedules, consistent with the terms of this Decision and Order (including footnote 9) with references to this Decision and Order and the applicable issued and effective dates.

#### II.

#### Orders

#### THE COMMISSION ORDERS:

1. Proposed Decision and Order No. 23916, filed on December 20, 2007, is adopted as the commission's Decision and Order in this proceeding.

3. NSW shall promptly re-file its revised tariff sheets and rate schedules, consistent with the terms of this Decision and Order (including footnote 9) with references to this Decision and Order and the applicable issued and effective dates.
