ORDER

By Decision and Order No. 23980, filed on January 25, 2008, the commission allowed NORTH SHORE WASTEWATER TREATMENT, L.L.C.'s ("NSW") revised tariff sheets and rate schedules to take immediate effect, and instructed NSW to re-file its revised tariff sheets and rate schedules, incorporating the applicable issued and effective dates.

The commission acknowledges receipt of NSW's re-filed tariff sheets and rate schedules, filed on January 30, 2008, which comply with Decision and Order No. 23980.¹

The commission accordingly orders that this docket is closed, unless otherwise ordered by the commission.


