#### ORDER

By this Order, the commission dismisses the application filed by THOMAS SPENCER, dba KALAHEO TRUCKING & EQUIPMENT RENTAL ("Applicant"), on August 21, 2007, and closes this docket.

I.

### Application for Common Carrier Authority

By application filed on August 21, 2007, and amended on September 6, 2007, Applicant requests a certificate of public convenience and necessity to operate as a common carrier of property by motor vehicle over irregular routes on the island of Hawaii in the dump truck and specific commodities (heavy machinery and equipment) classifications.

By a notice of dismissal dated January 15, 2008, we informed Applicant of our intent to dismiss the application without prejudice because of Applicant's failure to respond to the commission's request for information. Applicant was further advised that any objection to the dismissal of his application must be submitted in writing and filed not later than

ten (10) days from the date of the notice, and that if an objection was not filed, the commission would issue an order dismissing the application.

### Findings and Conclusions

Applicant did not object to the dismissal of his application within the ten (10)-day time period. We, thus, find that there is good cause to dismiss the application in this docket.

#### THE COMMISSION ORDERS:

The application filed by Applicant on August 21, 2007, is dismissed without prejudice and this docket is closed unless otherwise ordered by the commission.
