<u>ORDER</u>

By this Order, the commission issues this prehearing order as a result of the prehearing conference held on March 12, 2008, in preparation for the evidentiary hearing scheduled for March 17, 2008.

I.

Background

On November 13, 2007, the commission issued Prehearing Order No. 23827, and on January 25, 2008, by Order No. 23982, the commission amended Prehearing Order No. 23827 "by establishing certain dates to govern the remainder of this proceeding for a

II.

Discussion

The terms and provisions of Prehearing Order No. 23827, filed on November 13, 2007, and Order No. 23982, filed on January 25, 2008, as amended, are incorporated by reference herein, to the extent applicable. The issues governing this proceeding are set forth in the Notice of Evidentiary Hearing, dated February 15, 2008.

Consistent with the agreements reached and actions taken at the prehearing conference, and unless modified otherwise by the commission, the following terms shall control the evidentiary hearing and remaining course of this proceeding:

1. The Parties submitted the written testimonies of one witness each. All of these witnesses will appear and testify at the evidentiary hearing. All of the witnesses called to

testify shall be limited to orally summarizing his or her written testimony, and will be available for cross-examination.

- 2. WHWC's witness, Mr. Bruce Moore, will adopt WHWC's responses to Petitioner's information requests, filed on December 17, 2007, in place of Mr. Richard Terminello.
- 3. The order of witness presentation will be Petitioner, the Consumer Advocate, and WHWC.
- 4. The Parties' hearing exhibits shall be pre-marked as Petitioner's Hearing Exhibit ____, CA's Hearing Exhibit ____, and WHUC's Hearing Exhibit ____, as applicable.
 - 5. The Parties waive opening statements.
- 6. The Parties agreed that upon the conclusion of the testimony of the last witness, the Parties will decide whether closing arguments will be waived. Upon reflection, the commission hereby states its intent to proceed with closing arguments.
- 7. Petitioner informally responded to supplemental information requests issued by WHWC, which are not part of the docket record. Petitioner shall file its responses to WHWC's supplemental information requests with the commission.

III.

Order

THE COMMISSION ORDERS:

The terms set forth in this Order shall govern the evidentiary hearing and the remainder of this proceeding, unless modified or ordered otherwise by the commission.
