ORDER

By this Order, the commission closes this docket.

I.

Docket No. 2007-0256

By Order No. 23757, filed on October 24, 2007, in Docket No. 2007-0256, the commission ordered ISLAND NETWORK SERVICES, LLC, dba INS TOURS ("Respondent") to appear at 465 South King Street, Room B3, Honolulu, Hawaii 96813, at 9:00 a.m., on November 20, 2007, to show cause why Respondent's certificate of public convenience and necessity number 1785-C ("Certificate 1785-C") should not be suspended or revoked for failure to pay the civil penalty of \$1,000.00 associated with Citation No. 0921. As Respondent failed to appear before the commission's hearing officer on November 20, 2007, the commission, by Order No. 23905, filed on December 19, 2007, suspended Certificate 1785-C for a period of three (3) months,

effective from December 19, 2007. Ordering paragraph 2 of Order No. 23905 stated that if Respondent failed to pay the civil penalty of \$1,000.00 associated with Citation No. 0921 by the time the suspension period had expired Certificate No. 1785-C would be revoked.

## II.

### Docket No. 2006-0493

By Order No. 23256, filed on February 12, 2007, in Docket No. 2006-0493, the commission placed Certificate No. 1785-C on inactive status for a period of one year, until February 11, 2008. By Order No. 24071, filed on March 5, 2008, the commission revoked Certificate No. 1785-C as Respondent failed to reactivate Certificate No. 1785-C prior to the expiration of the period of inactivity, i.e., by February 11, 2008, as required by Hawaii Revised Statutes § 271-19(b).

## III.

### Findings and Conclusions

The revocation of Respondent's operating authority by Order No. 24071 in Docket No. 2006-0493 renders moot the proceedings in Docket No. 2007-0256. We, thus, conclude that there is good cause to close Docket No. 2007-0256 as moot.




