ORDER

By this Order, the commission approves the voluntary surrender of MOBILE ESPN, LLC's ("Petitioner") certificate of registration ("COR").

I.

Background

Petitioner holds a COR to provide commercial mobile radio services ("CMRS") on a resold basis within the State of Hawaii ("State"). On February 5, 2007, Petitioner submitted its 2006 Annual Financial Report, with the written notation that Petitioner ceased business as of December 31, 2006, and has "no [or] customers." letter Hawaii assets By dated February 14, 2007, the commission: (1) informed Petitioner that it will treat the written notation as a request to voluntarily surrender Petitioner's COR; and (2) instructed Petitioner to submit its 2007 Annual Financial Report and pay the applicable

public utility fees.² Thereafter, on March 13, 2008, the commission sent a Final Notice to Petitioner, with a due date of March 28, 2008.

II.

Discussion

Hawaii Administrative Rules ("HAR") § 6-80-123(c) provides in relevant part that for any telecommunications carrier whose entry into the intrastate telecommunications market is preempted by federal law, said carrier shall, not later than thirty days before the proposed effective date of any contemplated abandonment or discontinuance of service, provide a written notice of [its] intent to abandon or discontinue service to the commission, the consumer advocate, and affected customers."

Here, Petitioner has not responded to the Final Notice. Nonetheless, Petitioner has ceased its operations as of December 31, 2006, and a review of Petitioner's 2005 and 2006 Annual Financial Reports on file with the commission confirms that it did not generate any operating revenues within the State. Given Petitioner's non-provision of CMRS on a resold basis within the State, the commission, in lieu of revocation, approves the

voluntary surrender of Petitioner's COR, pursuant to HAR § 6-80-123(c).

III.

Order

THE COMMISSION ORDERS:

- 1. Petitioner's request to surrender its COR to provide CMRS on a resold basis within the State is approved, effective from the date of this Order.
- 2. This docket is closed unless ordered otherwise by the commission.
