

<u>ORDER</u>

By this Order, the commission vacates Decision and Order No. 23846 and closes this docket.

I.

Application for Common Carrier Authority

On November 20, 2007, in Decision and Order No. 23846, the commission approved the application of SURF & TURF SHUTTLE ("Applicant") to extend its SERVICE, LLCauthority under certificate of public convenience and necessity number 3566-C classification to include the 1-to-7 passenger on the island of Kauai. We also: (1) ordered Applicant, as a condition to our approval of the application, to comply with all commission requirements for common carriers, including submitting certain documents within one hundred and twenty (120) days of the issuance of the decision and order; and (2) notified Applicant that failure to timely comply with the commission's requirements for the commission would constitute cause to vacate the Decision and Order. We served Applicant with a copy of the Decision and Order by mail, postage prepaid, on the same day that the Decision and Order was issued, in accordance with Hawaii Administrative Rules §§ 6-61-21 and 6-61-122. Additionally, letter Applicant, we sent а to dated November 20, 2007, which reiterated the commission's requirements and specified March 20, 2008, as the deadline for compliance.

II.

Findings and Conclusions

The one hundred and twenty (120)-day time period has passed, and Applicant has not complied with the requirements set forth in Decision and Order No. 23846. The commission, thus, determines that Decision and Order No. 23846 should be vacated.

THE COMMISSION ORDERS:

Decision and Order No. 23846 is vacated and this docket is closed unless otherwise ordered by the commission.
