DECISION AND ORDER

By this Decision and Order, the commission revokes certificate of public convenience and necessity number 1751-C ("Certificate No. 1751-C") held by PATRICIA L. THATE, dba EUROPA HAWAII TOURS ("Respondent").

I.

Background

By Order No. 23936, filed on December 27, 2007, the commission suspended Respondent's Certificate No. 1751-C for a period of three (3) months, effective from the date of the Order, for failure to file an annual financial report ("AFR") and pay an annual motor carrier gross revenue fee ("Fee") for the year 2006. In our Order, we stated that if Respondent did not file an AFR and pay the Fee for the year 2006 by the time the suspension

period had expired, i.e., three (3) months from the date of the Order, Certificate No. 1751-C would be revoked.

II.

Findings and Conclusions

The suspension period of three (3) months has passed and Respondent has not filed an AFR and paid the Fee for the year 2006. The commission, thus, determines that Certificate No. 1751-C should be revoked.

III.

Order

THE COMMISSION ORDERS:

Certificate No. 1751-C is revoked, and this docket is closed unless otherwise ordered by the commission.


