By this Decision and Order, the commission vacates Order No. 22778, filed on August 22, 2006, in the matter of TONY ABDER S. ABURABI ("Respondent").

By Order No. 22778, filed on August 22, 2006, the commission ordered Respondent to appear at 465 South King Street, 96813, a.m., on Honolulu, Hawaii at 9:00 Room ΒЗ, September 27, 2006, to show cause why Respondent's certificate of public convenience and necessity number 1324-C should not be suspended or revoked for failure to pay the civil penalty of Citation with \$10,000.00 associated No. 0911. On January 7, 2008, Respondent paid in full the civil penalty of \$10,000.00, upon completing installment payments from March 1, 2007 to January 7, 2008.

Findings and Conclusions
