### Background

By Order No. 24029, filed on February 11, 2008, the commission placed Certificate No. 1032-C on inactive status for a period of one year, from March 1, 2008 to February 28, 2009. In the order, the commission informed Petitioner that if Certificate No. 1032-C was not reactivated prior to the expiration of the period of inactivity, i.e., by February 28, 2009, the commission would deem it to be abandoned and revoked, as required by Hawaii Revised Statutes § 271-19(b).

## Findings and Conclusions
