ORDER PLACING CERTIFICATE NO. 4578-C ON INACTIVE STATUS

By this Order, the commission places certificate of public convenience and necessity no. 4578-C ("Certificate No. 4578-C"), held by WAILEA LIMOUSINE SERVICE, INC. ("Petitioner"), on inactive status for a period of twelve (12) months, effective from the date of this Order, pursuant to Hawaii Revised Statutes ("HRS") § 271-19(b).

I.

Request to Place Common Carrier Authority on Inactive Status

On March 25, 2009, Petitioner filed a letter requesting that Certificate No. 4578-C be placed on inactive status. Certificate No. 4578-C authorizes Petitioner to transport passengers by motor vehicle over irregular routes on the island of Maui in the 1-to-7 and 8-to-25 passenger classification.

Under HRS § 271-19(b), the commission may place a certificate on inactive status upon written request by a motor carrier, and for good cause shown. The inactive period, however,

may not exceed twelve (12) months. In addition, HRS § 271-19(b) provides that inactive status may only be granted for a cumulative period not to exceed two (2) years over the life of the certificate. The commission finds that there is good cause to grant Petitioner's request.

II.

<u>Orders</u>

THE COMMISSION ORDERS:

- 1. Petitioner's Certificate No. 4578-C is placed on inactive status for a period of twelve (12) months, effective from the date of this Order.
- 2. Pursuant to HRS § 271-19(b), if Certificate No. 4578-C is not reactivated prior to the expiration of the period of inactivity, it shall be declared abandoned and revoked. The request to reactivate Certificate No. 4578-C, along with the filing of all documents necessary for reactivation must be completed prior to the expiration of the inactivity period, or Certificate No. 4578-C shall be revoked.
- 3. Petitioner shall not transfer its inactive certificate unless Petitioner can first establish good cause to the commission for the transfer, and the commission has approved the request to transfer.
