ORDER AMENDING DECISION AND ORDER FILED ON AUGUST 4, 2008

I.

By Decision and Order filed on August 4, 2008, the commission granted CHIEN-LIEN CHEN, dba D & J TRANSPORTATION ("Applicant"), a certificate of public convenience and necessity to operate as a common carrier of passengers by motor vehicle over irregular routes on the island of Oahu in the 1-to-7 and 8-to-25 passenger classifications.

On April 7, 2009, Applicant filed a letter requesting that his authority in the 1-to-7 passenger classification be surrendered. Accordingly, we find good cause to grant Applicant's request and amend the Decision and Order to reflect such surrender of authority.

II.

Orders

THE COMMISSION ORDERS:

1. Applicant's request to surrender his authority in the 1-to-7 passenger classification is granted.

2. The Decision and Order filed on August 4, 2008 is amended consistent with the terms of this Order. Specifically, ordering paragraph 1 of the Decision and Order is amended as follows:

"Applicant is granted a Certificate to operate as a common carrier of passengers by motor vehicle over irregular routes on the island of Oahu in the 8-to-25 passenger classification."

In all other respects, the Decision and Order remains unchanged.
