ORDER DISMISSING APPLICATION

By this Order, the commission dismisses the application filed by MOUNTAIN MOVERS, INC. ("Transferor") on January 12, 2009, and closes this docket.

I.

Application to Transfer Common Carrier Authority

On January 12, 2009, Transferor filed an application seeking commission approval to transfer Certificate No. 4132-C to Smart Move Van Lines, Inc., pursuant to Hawaii Revised Statutes ("HRS") § 271-18.

By a notice of dismissal dated March 24, 2009, we informed Transferor of our intent to dismiss the application without prejudice because of Transferor's failure to provide a Tax Clearance Certificate in the name of Transferor. Transferor was further advised that any objection to the dismissal of its application must be submitted in writing and filed not later than ten (10) days from the date of the notice, and that if an

objection was not filed, the commission would issue an order dismissing the application.

II.

Findings and Conclusions

Transferor did not object to the dismissal of its application within the ten (10)-day time period. We, thus, find that there is good cause to dismiss the application in this docket.

III.

Order

THE COMMISSION ORDERS:

The application filed by Transferor on January 12, 2009, is dismissed without prejudice and this docket is closed unless otherwise ordered by the commission.
