ORDER AMENDING DECISION AND ORDER FILED ON FEBRUARY 4, 2009

By this Order, the commission amends the Decision and Order filed on February 4, 2009.

I.

Background

By Decision and Order filed on February 4, 2009, the commission granted FREEDOM HAWAII TRANSPORTS LLC ("Applicant") a certificate of public convenience and necessity to operate as a common carrier of passengers by motor vehicle over irregular routes on the island of Oahu in the (1) 1-to-7 passenger classification, and (2) 8-to-25 passenger classification, limited to utilizing motor vehicles with a maximum manufacturer's seating capacity of 17 passengers.

On April 28, 2009, Applicant filed a letter requesting that its authority in the 8-to-25 passenger classification, limited to utilizing motor vehicles with a maximum manufacturer's seating capacity of 17 passengers, be surrendered, as it is not feasible for Applicant to operate in this classification at this time. Accordingly, we find good cause to grant Applicant's

request and amend the Decision and Order to reflect such surrender of authority.

II.

<u>Orders</u>

THE COMMISSION ORDERS:

- 1. Applicant's request to surrender its authority in the 8-to-25 passenger classification, limited to utilizing motor vehicles with a maximum manufacturer's seating capacity of 17 passengers, is granted.
- 2. The Decision and Order filed on February 4, 2009 is amended consistent with the terms of this Order. Specifically, ordering paragraph 1 of the Decision and Order is amended as follows:

"Applicant is granted a Certificate to operate as a common carrier of passengers by motor vehicle over irregular routes on the island of Oahu in the 1-to-7 passenger classification."

In all other respects, the Decision and Order remains unchanged.
