ORDER AMENDING DECISION AND ORDER FILED ON MARCH 10, 2009

By this Order, the Commission amends the Decision and Order filed on March 10, 2009.

I.

Background

By Decision and Order filed on March 10, 2009, NOKA'OI TRUCKING, INC. ("Applicant") was granted a certificate of public convenience and necessity to operate as a common carrier of property by motor vehicle over irregular routes on the island of Oahu in the general commodities and dump truck classifications.

On May 15, 2009, Applicant filed a letter requesting that its authority in the general commodities classification be surrendered, as it was not able to accommodate the vehicle requirements of this classification. Accordingly, we find good cause to grant Applicant's request and amend the Decision and Order to reflect such surrender of authority.

II.

Orders

THE COMMISSION ORDERS:

1. Applicant's request to surrender its authority in the general commodities classification is granted.

2. The Decision and Order filed on March 10, 2009 is amended consistent with the terms of this Order. Specifically, ordering paragraph 1 in the Decision and Order is amended as follows:

"Applicant is granted a Certificate to operate as a common carrier of property by motor vehicle over irregular routes on the island of Oahu in the dump truck classification."
