NOTICE OF VIOLATION, ORDER TO SHOW CAUSE, AND NOTICE OF HEARING

TON SERVICES, INC., dba FLYING J COMMUNICATIONS ("Respondent"), is the holder of a certificate of registration ("COR"), issued pursuant to Hawaii Administrative Rules ("HAR") § 6-80-18.

HAR § 6-80-91 requires Respondent to file an annual financial report ("AFR") by March 31 of each year. Hawaii Revised Statutes § 269-30 requires Respondent to pay a public utility fee ("Fee") in July and December of each year. Respondent failed to file its 2007 AFR and pay the Fees (based on 2007 gross revenues) that were due on July 31, 2008 and December 31, 2008.

HAR § 6-80-19 authorizes the commission, after notice and hearing, to suspend or revoke any COR, in whole or in part, if the commission finds that the holder violated any applicable Hawaii State laws, commission orders or rules. Accordingly, the

commission may suspend or revoke Respondent's COR for failure to comply with the legal requirements set forth above, unless Respondent is able to show cause why such suspension or revocation should not occur.

THE COMMISSION ORDERS:

- 1. Respondent shall appear at 465 South King Street, Room B-3, Honolulu, Hawaii 96813, at 9:00 a.m., on November 18, 2009, to show cause why Respondent's COR should not be suspended or revoked for failure to comply with the legal requirements set forth in this order.
- 2. Respondent may be represented by counsel. If Respondent does not retain counsel, Respondent may be represented at the hearing as follows: (a) an individual may appear on his or her own behalf; (b) a partner may represent a partnership; and (c) an officer or authorized employee of a corporation, trust, or association may represent the corporation, trust, or association.
- 3. If Respondent fails to appear at the scheduled hearing, Respondent's COR shall be suspended or revoked.
