On October 29, 2009, Respondent filed its HAW-PUC Form 03-020 for the year 2008.

# Findings and Conclusions

The commission finds that Respondent has fully complied, although belatedly, with the motor carrier laws, rules, and regulations, and concludes that the Notice, filed on October 14, 2009, should be vacated.
