ORDER SUSPENDING KONA TRANSPORTATION
COMPANY, INC.'S TRANSMITTAL


By this Order, the commission suspends KONA TRANSPORTATION COMPANY, INC.'s ("KTC") transmittal filed on October 20, 2009, for further commission review.¹ By December 11, 2009, KTC shall file with the commission, with copies served upon the Division of Consumer Advocacy, information and data that establish why KTC's proposed tariff changes to reduce by twenty percent certain charges related to shipments that traverse Saddle Road on the island of Hawaii, are just and reasonable.


¹By this Order, the commission does not open an investigation of KTC's proposed tariff changes, and thus, will not consider any motions to intervene or participate at this time. See Hawaii Administrative Rules § 6-61-57(3)(B) (motions to intervene or participate must be filed within twenty days after the commission orders the investigation of a proposed tariff change). Instead, the commission suspends KTC's transmittal for the purpose of reviewing additional information and data to be filed by KTC.
