ORDER VACATING NOTICE OF VIOLATION

By this Order, the commission vacates the Notice of Violation, Order to Show Cause, and Notice of Hearing ("Notice"), filed on October 16, 2009, in the matter of LEONARD MODESTO LABRADOR, dba L & Z HAULING ("Respondent").

I.

History

By Notice, filed on October 16, 2009, the commission ordered Respondent to appear at 465 South King Street, Room B-3, Honolulu, Hawaii 96813, at 9:00 a.m., on November 18, 2009, to show cause why Respondent's certificate of public convenience and necessity number 5157-C should not be suspended or revoked for failure to file an annual financial report ("AFR") and pay an annual motor carrier gross revenue fee ("Fee") for the year 2008, pursuant to Hawaii Revised Statutes ("HRS") §§ 271-25, 271-36,

and Hawaii Administrative Rules ("HAR") §§ 6-62-42(a), 6-62-24(a).

On November 4, 2009, Respondent filed his 2008 AFR, paid his Fee, and on November 9, 2009 paid \$152.83 in penalties and interest that the commission assessed, pursuant to HRS § 271-27(i), and HAR §§ 6-62-24(b)(c) and 6-62-42(d).

II.

Findings and Conclusions

The commission finds that Respondent has fully complied, although belatedly, with the motor carrier laws, rules, and regulations, and concludes that the Notice, filed on October 16, 2009, should be vacated.

THE COMMISSION ORDERS:


1. The Notice, filed on October 16, 2009, is vacated.


