## ORDER VACATING NOTICE OF VIOLATION

By this Order, the commission vacates the Notice of Violation, Order to Show Cause, and Notice of Hearing ("Notice"), filed on October 15, 2009, in the matter of A & S HAULING, LLC ("Respondent").

I.

#### History

By Notice, filed on October 15, 2009, the commission ordered Respondent to appear at 465 South King Street, Room B-3, Honolulu, Hawaii 96813, at 9:00 a.m., on November 18, 2009, to show cause why Respondent's certificate of public convenience and necessity number 5232-C should not be suspended or revoked for failure to file an annual financial report ("AFR") and pay an annual motor carrier gross revenue fee ("Fee") for the year 2008, pursuant to Hawaii Revised Statutes ("HRS") §§ 271-25, 271-36,

and Hawaii Administrative Rules ("HAR") §§ 6-62-42(a), 6-62-24(a).

On November 3, 2009 and November 13, 2009, Respondent 2008 and on November 3, 2009 filed its AFR, November 13, 2009, Respondent paid its Fee. In addition, on November 3, 2009 and November 13, 2009, Respondent paid \$299.06 and \$271.32, respectively, in penalties and interest that the commission assessed, pursuant to 271-27(i), HRS § and HAR §§ 6-62-24 (b) (c) and 6-62-42 (d).

### Findings and Conclusions

The commission finds that Respondent has fully complied, although belatedly, with the motor carrier laws, rules, and regulations, and concludes that the Notice, filed on October 15, 2009, should be vacated.
