ORDER APPROVING KONA TRANSPORTATION
COMPANY, INC.'S TRANSMITTAL


By this Order, the commission approves KONA TRANSPORTATION COMPANY, INC.'s ("KTC") transmittal filed on October 20, 2009, effective from the date of this Order. KTC, in support of its proposed tariff changes to reduce by twenty percent certain charges related to ground shipments that traverse Saddle Road on the island of Hawaii, states that the improvements to Saddle Road have: (1) greatly reduced the travel time for ground shipments that traverse Saddle Road; and (2) also reduced the maintenance required for its trucks.¹ KTC shall promptly file with the commission, with copies served upon the Consumer Advocate, its revised tariff sheets with the applicable issued and effective dates.


