DCCA DISCIPLINARY ACTIONS

HONOLULU - The Department of Commerce and Consumer Affairs (DCCA) and the State Boards and Commissions released a summary of disciplinary actions through the month of October taken on individuals and entities with professional and vocational licenses in Hawai'i.
