Executive Officer's Report:	 A. <u>Council on Chiropractic Education (CCE)</u> 1. February 11, 2013 CCE Accreditation Actions Announcement. 				

The announcement was distributed to members informing them of the accreditation actions taken by the Council at its January 2013 Annual Meeting.

Executive Officer Bhanot explained that CCE seeks to ensure the quality of chiropractic education in the United States by means of accreditation, educational improvement and public information. CCE develops accreditation criteria to assess how effectively programs or institutions plan, implement and evaluate their mission and goals, program objectives, inputs, resources and outcomes of their chiropractic programs.

The Board would like to further advise Dr. Galla that Hawaii Board of Chiropractic Examiners does not license by reciprocity. One must meet the examination requirements as set forth in Hawaii Revised Statutes (HRS) §442-6.

B. <u>January 19, 2013 email from Darren De Mello Re: Use of</u> <u>Class IV lasers in the Chiropractor field of medical care</u>

At 10:29 a.m., it was moved by Ms. Kang-Kaulupali, seconded by Dr. Redmond, and unanimously carried to return to open session. The room was reopened to the public.

B. <u>January 19, 2013 email from Darren De Mello Re: Use of</u> <u>Class IV lasers in the Chiropractor field of medical care</u>

Discussion followed. It was moved by Dr. Redmond, seconded by Ms. Kang-Kaulupali, and unanimously carried the following response to Mr. DeMello's inquiry:

"Does Hawaii allow a Chiropractor Doctor to administer treatments of class IV lasers?" "Does this type of treatment fall under the scope of practice for a Chiropractor Doctor to use class IV lasers?" Chiropractic licensees may administer treatments within the definition of chiropractic and within the scope of practice. The Board informally opined that the use of class IV lasers appears to be within the chiropractic scope of practice. See Hawaii Revised Statutes ("HRS") §442-1 and Hawaii Administrative Rules (HAR)§ 16-76-25.

"Does Hawaii allow the Chiropractor Doctor or may a trained and certified massage therapist administer the treatments of class IV lasers?"

In accordance with HRS §442-2(a), "It shall be unlawful for any person to practice chiropractic without a license." The Board does not regulate the practice of massage therapy. The regulation of massage therapy is governed by the Board of Massage Therapy, HRS Chapter 452.

"If these fees for treatment are approved by the board?"

The Board does not have jurisdiction to regulate fees a chiropractic licensee charges for services such as laser treatments.

In accordance with HAR §16-201-90, the above interpretation is for informational and explanatory purposes only. It is not an official opinion or decision, and thus, is not to be viewed as binding on the Board.

C. <u>February 4, 2013 email from Robert C. Nelson, D.C.</u>, <u>American Chiropractic Board of Sports Physicians</u> <u>Re: Concussion survey</u>

After a short discussion, it was moved by Ms. Kang-Kaulupali, seconded by Dr. Redmond, and unanimously carried to inform Dr. Nelson that Hawaii law does not specifically reference the extent to which a chiropractic licensee may evaluate, manage, and determine return to play for concussions.

The Board informally opined that it may be permitted to the extent evaluation, management and/or determination falls within the chiropractic scope of practice as defined in Hawaii Revised Statutes § 442-1 and Hawaii Administrative Rules § 16-76-25.

In accordance with HAR §16-201-90, the above interpretation is for informational and explanatory purposes only. It is not an official opinion or decision, and thus, is not to be viewed as binding on the Board.

D. <u>February 17, 2013 email from Eric Russell, D.C.</u> President – New Zealand College of Chiropractic

The Board reviewed and discussed the above email inquiry from Eric Russell, D.C. His request for the Board to evaluate the New Zealand College of Chiropractic curriculum is not within the Board's jurisdiction as the educational requirements are specified in the statutes and rules. However, the Board appreciated the sharing of the curriculum information.

The Board recommended Dr. Russell refer to HRS 442-2 and HAR 16-76-8 for the educational requirements for chiropractic licensure.
