Old Business:	Α.	New Zealand College of Chiropractic				
		Executive Officer Bhanot informed the Board that at its meeting on March 7, 2013, the Board discussed an email from Eric Russell, D.C. requesting the Board to evaluate the New Zealand College of Chiropractic curriculum. Dr. Russell also indicated that a package containing the curriculum information would be sent to the Board.				
		Ms. Bhanot explained that on April 10, 2013, she received a letter dated March 4, 2013 from Dr. Pieter M. Kachelhoffer along with the curriculum and quality management system information. For informational purposes, Ms. Bhanot shared with the Board the materials received.				
		Dr. Klein indicated that this is not the first that the Board received inquiries concerning educational requirements for foreign graduates. Dr. Klein further indicated that such inquiries will continue to grow and inquired what steps are required from the licensing Board to make changes to the existing law and rules to allow future participation from foreign colleges.				
		Executive Officer Bhanot explained that the Board's educational requirements for chiropractic licensure are specified in the statutes and rules. She further explained that the Board has a list of foreign colleges that meets the accreditation requirements.				

After further discussion, once again the Board is recommending Dr. Russell refer to the Hawaii Revised Statutes ("HRS") Chapter 442 and Hawaii Administrative Rules ("HAR") Title 16, Chapter 76 which specifically address the educational requirement for chiropractic licensure.

Ms. Bhanot also informed the Board that a list of the accredited foreign schools will be provided at its next Board meeting.

<u>Correspondence</u>: A. <u>March 22, 2013 email from Allen S. Miller Re: Dr. Glenn</u> <u>Poulain.</u>

> The Board reviewed an email from Allen S. Miller, in which he informed the Board that Dr. Poulain is using and marketing a non FDA approved device for weight loss and is on several websites using a "Cavi-Lipo Ultrasound Cavitation device. Mr. Miller is asking the Board if this is legal under Hawaii State Law.

After further discussion, it was moved by Ms. Kikuta, seconded by Dr. Redmond, and unanimously carried to inform Mr. Miller that chiropractic licensees may administer treatments within the definition of chiropractic and within the scope of practice. The Board informally opined that the practice of chiropractic may include the use of therapeutic ultrasound, subject to the restrictions contained in chapter 442, Hawaii Revised Statutes ("HRS") specifically, HRS §442-1 for activities that constitute the practice of chiropractic.
