		Executive Officer Bhanot informed members that FCLB

		hosted its 87 <sup>th</sup> Annual Educational Congress on May 1-5 in San Francisco, California. Ms. Bhanot indicated the highlights of the conference included educational sessions – issues in licensure and practice. Ms. Bhanot further indicated that awards were given out to respective individuals.
		Ms. Kang-Kaulupali inquired as to whether the Board would cover expenses for Board members to attend these meetings.
		Dr. Klein explained that the Hawaii Board of Chiropractic Examiners is not funded to attend the FCLB meetings.
		Dr. Klein pointed out to members FCLB's program for certifying and regulating chiropractic clinical assistants and its components of the program.
		Dr. Klein informed members that chiropractic assistants training and monitoring has become a regulatory concern for the 40 US jurisdictions, who have no regulatory oversight of chiropractic assistants. Presently, 11 states require some type of training. Dr. Klein went on to say that his staff will be attending the training.

See Hawaii Revised Statutes ("HRS") § 442-1. In addition, the Board suggested Dr. Leomo contact the Department of Labor and Industrial Relations (DLIR) for further guidance and assistance with TDI regulations.
