6. <u>New Business</u>: f. <u>Matters Relating to the North East Regional Board of Dental</u> Examiners, Inc. ("NERB")

• June 2012 Steering Committee Report

Ms. Nakagawa made the following report:

 ADEX is an organization of State Dental Boards and its goal is the development of a National Uniform Exam.

As of June 7, 2012, 29 states are members of ADEX and 43 states accept the ADEX examinations

 Page 7 of The NERB DH Candidates Manual will be corrected to clarify that the ADEX Examination Committees develop the examinations and NERB administers the examinations.

- In 2013, the Southern Regional Testing Agency ("SRTA") will administer the ADEX.
- ✓ The name/title of the ADEX Examinations has changed. The "ADLEX" to "ADEX Dental Examination" and the "ADHLEX" to "ADEX Dental Hygiene Examination".
- Occupational Task Analyses determine the content of what is tested on the exams (e.g. why important procedures such as fabricating temporaries, intra/extra oral examinations, extractions, etc. are not tested.)
- ✓ The Report on the 2012 February/March examinations was reviewed with the steering committee and educator audience.
- The Electronic Scoring Platform Committee reported that their goals are utilization of technology to improve the flow, decrease grading time = increase testing time (e.g. 90 minutes to 2 hours), increase accuracy, and to ensure equity and anonymity.

They are looking into a "Kindle" sized tablet which enables "Q-tip" scrolling to address infection control issues.

Currently, having IT personnel at each dental hygiene ("DH") exam is cost-prohibitive, but that is the goal. NERB has asked ADEX to review SRTA's automated platform for the DH testing.

- ✓ The Alpine Testing presentation included discussion on psychometric considerations on test construction. The test of minimal competency must be valid, reliable and fair, as well as cost-effective. It has nothing to do with what task may be valuable (i.e. intra/extra oral examinations, extractions, temporary construction, periodontal procedures, etc.)
- c. <u>Matters Related to the American Association of</u> <u>Dental Boards ("AADB")</u>

Presentation on AADB Assessment Services Program

Dr. Shampaine gave a comprehensive presentation on the AADB Assessment Services Program which includes the Dentist-Professional Review and Evaluation Program ("D-PREP").

The intent of D-PREP is to detect, evaluate and suggest possible remediation of deficiencies in practitioners referred to the program by their boards. This program is not designed for the impaired practitioner. Currently, there are assessment centers at the University of Maryland, Marquette University and Louisiana State University.

There was a question on how a practitioner's actions would be brought to the Board's attention.

Dr. Shampaine said primarily through patient complaints.

One of the members noted that in Hawaii, investigation into complaints is done through RICO and questioned how the practitioners would be referred to the program.

Dr. Shampaine noted that nationally, there are three types of dental boards. There are boards that are completely independent (fully funded with their own staff including investigators), boards such as Hawaii that uses an outside investigative agency, and boards which are a hybrid of the two.

There was an inquiry on the cost and who paid for the program.

Dr. Shampaine stated that the cost of the program is determined by each assessment center and noted that practitioners are responsible for the cost of the program.

The Board thanked Dr. Shampaine for his presentation.

e. <u>Matters Relating to the American Board of Dental Examiners</u> ("ADEX")

Ms. Nanette Kosydar Dreves conducted her presentation on the ADEX Dental Hygiene Examination reviewing the updates to the dental hygiene examination and information on the ADEX governing structure. ADEX does not administer any examinations. They are a test development organization that develops dental and dental hygiene exams which are administered by NERB. ADEX currently has 29 member states. 43 states recognize ADEX and accept their exam results.

<u>Recess</u>: At 10:43 a.m., Chair Baird called for a recess.

<u>Reconvene</u>: At 10:55 a.m., the Board returned to its regular order of business.

b. <u>Discussion on Continuing Education</u>

Mr. Hassler gave a brief overview of RICO and stated that when the Board refers continuing education ("CE") complaints to RICO, they conduct an investigation. After speaking to his staff, generally, the practitioner is sent a letter asking for an explanation for not submitting the requested documentation to the Board as a "last chance" before a case is initiated. He noted that each investigation is done on a case-by-case basis and every situation is different.

It was questioned why RICO felt the need to ask for an explanation when the Board has already deemed the practitioner deficient. Oftentimes, the Board has already sent correspondence and given additional time to comply. By the time the complaint is referred to RICO, the Board expects RICO to take action and not duplicate the Board's previous efforts.

Mr. Hassler stated that the letters are sent as part of RICO's normal procedures.

The Board inquired what would make it easier for RICO to conduct their investigation and ultimately, discipline these practitioners.

Mr. Hassler said if that is what the Board is interested in, he would have to find out what RICO can do.

The Board expressed frustration because they are limited in what they can do and they want to express their concern over the handling of practitioners' non-compliance with the CE requirement.

> It was stated that the Board granting extensions to comply with the CE requirements does not negate the fact that the practitioners are in violation as they did not comply with the law in a timely manner. As the enforcement arm of the Board, when all efforts have been exhausted by the Board and its officers, the Board must delegate to RICO to investigate and prosecute. On a case-by-case matter, RICO should consider appropriate fines and/or forfeiture of license as per language found in §436B, 447 and 448, Hawaii Revised Statutes.

Mr. Hassler said he would talk to the investigators and inform them of the Board's wishes.

One of the members expressed concern that the process of submitting CE documentation is antiquated and suggested that the State consider investing in modernizing their system.

j. <u>Election of Officers</u>

The floor was opened for nominations for Vice Chair.

It was moved by Dr. Wada, seconded by Ms. Grey, and unanimously carried to nominate and elect Ms. Nakagawa as Vice Chair of the Board for the upcoming year.

The floor was opened for nominations for Chair.

It was moved by Dr. Vallejos, seconded by Ms. Nakagawa, and unanimously carried to nominate and elect Dr. Baird as Chair of the Board for the upcoming year.

4. <u>Applications</u>: b. <u>Application for Dental Hygiene License – Lana Monestier</u>

After discussion, it was moved by Ms. Nakagawa, seconded by Dr. Wada, and unanimously carried to deny Ms. Monestier's dental hygiene application as she does not meet the examination requirement pursuant to section 447-1, HRS.

c. <u>Application for Community Service License – Dentist –</u> <u>Michael Olmstead</u>

> After discussion, it was moved by Dr. Wada, seconded by Ms. Nakagawa, and unanimously carried to direct Mr. Kobashigawa to determine if the supervised dental assistants will be working on live patients. If so, the Board believes that would constitute the practice of dentistry which would require a license. Since Dr. Olmstead stated the supervised dental assistants would be working on live patients and he does not meet the requirements of passing the National Board Dental Examination Part II within the last five years or being in active practice of clinical dentistry of not less than one thousand hours per year for the three years immediately prior to the date of request, Dr. Olmstead's application for a community service license would be denied.

7. <u>Correspondence</u>: a. <u>E-mail from Eric Muraoka</u>

Dr. Muraoka inquired whether he could use the clinical portions of his passed Western Regional Dental Exam ("WREB") and qualify it as a completed requirement toward the ADEX examination requirement.

It was moved by Dr. Sherman, seconded by Dr. Chun, and unanimously carried to deny Dr. Muraoka's request as he will need to comply with the current requirement, which is to pass the ADEX dental licensure exam, pursuant to section 448-9.4, HRS.

The Board returned to its regular order of business.

d. Discussion on 2012 Legislation

Act 247 (H.B. 2257, H.D.1, S.D.1 – Relating to Professional and Vocational Licensing)

This Act permits licensure by endorsement or licensure by reciprocity in certain situations for a nonresident military spouse. It establishes procedures for a nonresident military spouse to receive a license by endorsement or license by reciprocity and permits issuance of a temporary license if certain requirements are met. This bill also requires the licensing authority to expedite consideration of the application and issuance of a license by endorsement, license by reciprocity, or temporary license to a qualified nonresident military spouse.

Act 248 (H.B. 2258, H.D.2, S.D.1 – Relating to Professional and Vocational Licensing)

This act requires professional and vocational licensing boards to consider relevant military education, training, and service as part of the evaluation process toward the qualification of a license.

There was discussion on how to best implement the Act.

By consensus, the Board approved the creation of an applications committee to determine the best way to handle implementation of Act 247 and Act 248. The committee will be composed of Dr. Chun, Dr. Guevara, Ms. Nakagawa, Dr. Ota and Dr. Sherman.

Dr. Vallejos was excused form the meeting at 12:33 p.m.

k. <u>Request for approval of CE Course – American Trauma</u> <u>Event Management</u>

> It was moved by Dr. Guevara, seconded by Dr. Chun, and unanimously carried to approve American Trauma Event Management's CE course.

I. <u>Request for Modification of CE Requirement – Cindy (Kam)</u> Inayoshi

Ms. Inayoshi requested a modification of the CE requirement. Due to an ailment, she is not able to perform CPR and would like the Board to permanently waive the CPR requirement.

After discussion, upon a motion by Dr. Guevara, seconded by Dr. Ota, it was voted on to approve Ms. Inayoshi's request with Dr. Guevara, Dr. Ota, Dr. Baird, Dr. Chun, Ms. Grey, Dr. Sherman, and Ms. Nakagawa voting "Yes", and Ms. Nonaka voting "No". The motion passed.

7. <u>Correspondence</u>: a. <u>E-mail from Nic van der Lee Relating to Dental Assistants</u> <u>Performing Intra-oral Scanning on Patients for Crown, Inlay,</u> <u>and Only Design as Part of CAD/CAM</u>

> Mr. van der Lee inquired whether dental assistants can legally perform intra-oral scanning on patients for crown inlay, and only design as part of CAD/CAM, for example the CEREC and E4D systems.

By consensus of the Board, this matter will be deferred.

Dr. Sherman was excused from the meeting at 1:06 p.m.

b. <u>E-mail from California Center for Advanced Dental Studies</u> <u>Relating to Requirements for Licensure of Instructors and</u> <u>Lecturers</u>

The California Center for Advanced Dental Studies

> ("CCADS") inquired as to what type of license would be required for out-of-state or out-of-country dentists, hygienists and assistants if they are teaching for their program and involved with hands-on clinic work with live patients? CCADS is a post-graduate dental education program for dentists and their team members. Each program is 4 days in length (2 lecture days and 2 clinical days).

By consensus of the Board, this matter will be deferred and directed Mr. Kobashigawa to inform CCADS of the statutes 448-1(3) and if they do not meet this exemption, this program will need board approval.

c. <u>E-mail from Research Corporation of the University of</u> <u>Hawaii ("RCUH") Relating to Temporary or Community</u> <u>Service License</u>

The RCUH inquired whether a dentist with a community service license or a dentist with a temporary license could be hired for their University of Hawaii Oral Health Project. The dentist would conduct basic dental exams (no x-rays) and preventive care (fluoride varnish and sealant for all and temporary fillings only for those who need urgent care) to 3rd graders in after-school programs who have received signed parental consent. The dentist would continue their current employment while spending their afternoons for 1 to 2 weeks for this project.

By consensus of the Board, the RCUH will be notified that they can hire a dentist with a temporary license to do this work at the schools, or contract with a qualifying community service agency with a licensed community service dentist to perform the work for them.

8. <u>Executive</u> a. <u>Lawsuit Against Ohio State Dental Board</u>

The Ohio State Dental Board was recently sued by a dentist who is licensed as a specialist. The dentist would like to also practice general dentistry, however, Ohio's laws do not allow this practice.

The Colorado Department of Public Health and Environment recently found that a Denver oral surgeon has been reusing syringes and needles during oral and facial surgery procedures, and for intravenous (IV) medications, including for sedation.
