Mr. Kobashigawa reported that through the Hawaii Convention Center, a bid to host the 2018 Annual Meeting in Hawaii was submitted. No word yet whether the bid has been accepted.

April 2013 Candidate Survey Results

Exam candidates were surveyed after the exam and the results are as follows:

 Addendum to Contract Between NCEES and Member Board

At the April Board meeting, the Board discussed whether to keep the contract with NCEES regarding the administration of the exams as the Board would no longer be invoiced for any of the fees associated with the administration of the exams. In lieu of a contract, some state boards have accepted a letter from NCEES that details the services that will continue to be provided to them. The Board deferred this matter to wait and see the new changes to the contract that NCEES would be preparing.

NCEES Social Media Webinar Series

Metallurgical and Materials Engineer Professional Activities and Knowledge Study ("PAKS")

NCEES is seeking licensed metallurgical and materials engineers to participate in a PAKS for the PE Metallurgical and Materials exam, the results of which will be used to update specifications for the exam.

Continuing Education Survey of State Licensing Boards

Mr. Kobashigawa circulated a summary of the continuing education requirements of the other state boards.

2013 NCEES Engineering Award

Cleveland State University's Civil and Environmental Engineering Department is the \$25,000 grand prize winner of the 2013 NCEES Engineering Award for Connecting Professional Practice and Education. The department received the prize for is submission "Design, Funding, and Construction of the August Pine Ridge School/Hurricane Shelter in Belize" that would construct a building to provide additional classroom space for the school and also serve as a hurricane shelter for the community.

2013 NCARB Annual Meeting

The 2013 Annual Meeting is scheduled for June 19-22, 2013 at the U.S. Grant Hotel in San Diego, CA. Mr. Yumol, Mr. Murayama, and Mr. Kobashigawa will be attending this meeting.

✓ WCARB Regional Meeting

The 2013 WCARB Regional Meeting will be held in conjunction with the NCARB Annual Meeting on June 21, 2013 at the U.S. Grant Hotel in San Diego, CA.

- NCARB Fast Facts Articles
 - ✓ NCARB has created a library of communication tools that can be used to communicate the changes to the A.R.E. Materials include "My Examination FAQs", "Candidate Tip Sheet", and "My Examination Fact Sheet".
 - ✓ Two proposed changes to the IDP Guidelines were distributed to Member Boards for comment:
 - ➤ A proposed change recommends that interns be allowed to earn IDP hours for short employment periods. This will allow interns to earn experience for work performed over winter and spring breaks while in school and projects of limited scope with completion time in weeks. Currently, interns (in most experience settings) must be employed a minimum of 15 hours per week for eight consecutive weeks.
 - Another proposed change recommends that the point of eligibility to participate in the IDP be after obtaining a U.S. high school diploma or the equivalent. Interns will be able to earn IDP credit for work and supplemental experience that meet the requirements of the program.

- ✓ With the support from AIA, NCARB will be hosting the 2013 IDP Coordinators Conference on July 25-27, 2013 in Miami, FL. This conference has proven to be a great venue for training, information sharing, and teaming of IDP educator, state, student, and auxiliary coordinators.
- Architectural Registration Examination ("A.R.E.") Updates
 - ✓ Blackout begins July 1, 2013

Reminder that July 1, 2013 is the start of an estimated eight week blackout where exams cannot be administered or scheduled, and registration boards cannot create eligibilities for exam candidates. Exams can be scheduled immediately following the blackout which is expected to end in late August.

Following the blackout, Prometric will be implementing its biometric-enabled check-in procedures for the A.R.E. For the first biometric-enabled check-in, candidates will have their photo ID scanned, need to provide six (6) digital fingertip swipes (three (3) from each hand), as well as a test-day photo. Subsequent biometric-enabled check-ins will require only one (1) finger swipe and a test-day photo.

NCARB News Clips

NCARB announced the publication of the Examination Report based on the findings of the 2012 NCARB Practice Analysis. NCARB also announced that the fees for the Broadly Experienced Architect ("BEA") Program have been reduced.

Correspondence: a. AIA Hawaii Announcement of A.R.E./IDP Concurrency

AIA Hawaii sent out an announcement that the Board's rules relating to A.R.E./IDP concurrency was signed by the Governor on May 10, 2013. However, it was a little premature as the Board was still awaiting for the official notification from the Governor and as a result the process and procedure to register for the A.R.E. with NCARB was not in place.

b. Letter from Bruce Alexander, PE

Mr. Alexander inquired whether a civil engineer is able to work on specialty foundations such as Helix Anchors, Ground Screws, Ground Spikes/Pins and Micro Piles.

After discussion, it was moved by Mr. Lau, seconded by Ms. McCelvey, and unanimously carried that a civil engineer, with appropriate qualifications and proficiency in geotechnical engineering, may perform work on specialty foundations such as Helix Anchors, Ground Screws, Ground Spikes/Pins and Micro Piles. However, the Board also wanted to caution that a civil engineer must work only in his or her area of expertise.
