<u>Call to Order:</u> The Chair called the meeting to order at 9:27 a.m. at which time quorum was established.

#### Approval of the Minutes:

The Chair called for a motion in regards to the minutes of the March 7, 2013 meeting.

Ms. Stone Murai stated that on page 3, second paragraph under "Nurses Administering Botox and Dermal Fillers, Dr. Michael Dang" correct, "beyond the RN's scope of practice" to read, "beyond the scope of what is taught in the basic nursing curriculum."

Ms. Cohen stated that on page 4, second paragraph under "Family Nurse Practitioner Administering Botox and Fillers, Jennifer Lee" should also be corrected to reflect the Board's response to scope of practice questions.

There being no further corrections, upon a motion by the Vice Chair, seconded by Ms. Cohen, it was voted on and unanimously carried to approve the minutes as amended.

The Chair and Ms. Stone Murai attended the NCSBN 2013 Midyear meeting held March 11-13, 2013 in San Jose, California.

Ms. Stone Murai reported that as one of three representatives funded by the NCSBN from Hawaii, she participated in all sessions and events. NCSBN 2013 updates and committee reports included:

- NCSBN updates and committee reports including NCSBN's participation in the Tri-Regulator Symposiums which consist of representatives from Nursing, Medical and Pharmacy Boards. The group issued a consensus statement that recognizes that complementary expertise benefits patients they might include other disciplines in the future and that the number one issue is compounding drugs;
- NCSBN is an associate member of the Council of State Governments and is working with them to promote requirements for background checks;
- The current phase of the Transition to Practice Study ended in March and phase 2 will be starting;
- The 1st cohort in the Simulation Study will take the NCLEX this year. They will be followed for a year to monitor clinical competency and critical thinking.
- The Interface Group is looking at compact/noncompact states and the impact of ACA:
- Telemed is considered interstate commerce and can therefore be overseen by Congress. Issues are whose jurisdiction prevails and is state based licensure unconstitutional;
- Medical tourism is growing with 50 countries identifying it a major industry. Nursing standards vary. The EU recently proposed to decrease standards for entry into nursing programs to 10<sup>th</sup> grade education. Guam will soon be opening a medical tourism hospital.
- The Distance Learning Committee presented an update of their charge to identify regulatory issues related to distance learning and to develop model rules and regulatory standards for distance learning programs. The committee was looking only at prelicensure education, the number one issue is clinical experiences in distant states. They have developed a draft Uniform Checklist for Distance Learning Prelicensure Nursing Programs;

### Chair's Report:

- The Member Board Agreement Review Committee has proposed changes to streamline the document and amend the Bylaws accordingly. Pending BOD approval, these will be considered at the 2013 annual meeting;
- A representative from the VA Office of Nursing Services presented their implementation of the APRN Consensus Model which will move VA APRNs toward independent practitioners with full practice authority. They have developed a Handbook and an action plan;
- The Advanced Practice Committee reported on the Application of Grandfather Provisions for APRNs. They have drafted information and recommendations for additions to the Model Acts and Consensus Model.
- The Business Book from the meeting is available for Board members' review.

<u>Vice Chair's Report</u>: No report

Education Committee Report :

Ms. Cohen reported on the March 7, 2013 Education Committee:

- Accept quarterly report for Hawaii Pacific University. Based on the analysis and assessment of the intervention remedies being taken in respect to the low pass rate, the Committee decided that upon review of the annual report due in October 2013, they will re-evaluate if the submission of additional reports is necessary.
- Accept quarterly report for Hawaii Community College. Based on the analysis
  and assessment of the intervention remedies being taken in respect to the low
  pass rate, the Committee decided that upon review of the annual report due in
  October 2013, they will re-evaluate if the submission of additional reports is
  necessary.
- Accept quarterly report for University of Phoenix. Next quarterly report for the period covering January – March 2013 is due for the Committee's review at their May meeting.
- Annual pass rates for the Hawaii nursing programs Kauai Community College's
  pass rate was below 90% of the national pass rate along with Hawaii Community
  College and Hawaii Pacific University. Kauai Community College will be notified
  and the Committee will review the annual report due in October 2013, and reevaluate if they should be put on quarterly reports.

Ms. Cohen also reported that she is reviewing the Accreditation Self-Study Report for Chaminade University of Honolulu, School of Nursing and that the Committee is also discussing the national concern of MEPN students being allowed to take the NCLEX-RN exam without having a nursing degree. She also reported that the Committee responded to inquiries from distance learning nursing programs and an inquiry regarding the clinical requirements for nurse licensure.

Upon a motion by the Vice Chair, seconded by Ms. Fleming, it was voted on and unanimously carried to accept the Education Committees report.

# Practice Committee Report:

Ms. Stone Murai reported on the April 4, 2013 Practice Committee:

- On March 28, 2013, the proposed rules were approved by the governor so the Committee can now move forward with collapsing the structure of the APRN and APRN-Rx applications and removing multiple fees;
- The Committee also discussed correspondence relating to nurses dispensing medications out of the family planning community. The medications in question are non-controlled medications, for example birth control pills and STD medications. The Committee understands that although nurses, including APRNs may not dispense prescription drugs, except for non-control samples, an APRN may be able to act as an authorized agent of a physician. The Committee will be researching what federal and state regulations cover this practice and report back at the next practice committee meeting.

Upon a motion by the Vice Chair, seconded by Ms. Fleming, it was voted on and unanimously carried to accept the Practice Committees report.

# Executive Officer's Report:

### 2013 Legislature - Status Report on Nursing Bills

The EO reported on the status of the following bills:

#### SB 490, SD2/HB 654, HD2 - Relating to Nursing

SB 490 was not scheduled for hearing when it crossed over to the House.

HB 654, HD 2, SD1 crossed over to the Senate, was heard and amended and will probably go to conference if the House does not agree with the amendments made by the Senate.

#### SB 198/HB 79, HD1 – Relating to Advanced Practice Registered Nurses

SB 198 was not scheduled for hearing when it crossed over to the House.

HB 79, HD1 crossed to the Senate, scheduled for hearings and passed out unamended.

#### SB 655 – Relating to Health

SB 655, SD2, HD2 was heard by the House committees and passed out with amendments. Will probably go back to the Senate who will agree or disagree with the House amendments. If disagree, may go to conference.

#### SB 44 – Relating to Mental Health

SB 44, SD1, HD1, was heard by the House committees and passed out with amendments. Will probably go back to the Senate who will agree or disagree with the House amendments. If disagree, may go to conference.

#### SCR 66/SR 34 and HCR 53/HR 35

SCR 66/SR 34 was scheduled for hearing this morning, will report on outcome of hearing at the next Board meeting.

HCR 53/HR 35 was heard and amended by the House Committee on Health and will be referred to the Finance committee.
