Upon a motion by Ms. Tali, seconded by Ms. Elvenia, it was voted on and unanimously carried to accept the Committee's recommendations.

Executive Officer's Hawaii State Center for Nursing (HSCFN)

Presentation by Kathy Yokouchi

Ms. Yokouchi thanked the Board for allowing her to speak today. Ms. Yokouchi stated the National Council State Boards of Nursing (NCSBN) sees the Hawaii Board as the little engine that could, because despite the fact that the Board is under staffed, seeing as a Board with 24,000 nurses normally has eleven full time employees, NCSBN feels if Hawaii can get it done with minimal staff then how come the rest of you can't.

Ms. Yokouchi provided the Board with a comparison sheet she created, comparing the NCSBN Model Act to the Hawaii laws. Ms. Yokouchi stated there were three acts that were passed that the Board was very instrumental in getting these acts passed. Act 169 required insurers as well as HMOs to recognize APRNs as primary care providers, and authorize APRNs to certify or endorse documents from the Department of Health, Department of Education, etc. Act 57 aligned Chapter 457 and Chapter 89 to the scope of practice part of NCSBN Model Act. Finally Act 110 required each hospital to allow APRNs to practice to the full extent of their education and training. Ms Yokouchi stated, as you know the Center became aware that APRNs were still having barriers and the barrier was other departments, like the Department of Health, Department of Education, because of lack of information about where nursing has been going in the last decade, haven't changed their laws. So all these Acts were to try and do that, but because they didn't do it, Roz Baker is putting together some bills to try and get the other departments statutes together and place these changes in their laws too.

Ms. Yokouchi stated as far as amendments, there are three changes that she would like to present for the Boards consideration. The first one is to change APRN recognition to APRN license. Ms. Yokouchi stated DCCA used to, or maybe still does, consider license as requiring an examination, which is why APRNs were given recognition rather than license. However, when you look at the Model Act as well as many other state boards of

nursing they use "license". So if we can change APRN recognition to license, then Hawaii would be number seven in the nation to adopt the APRN consensus model in its entirety. The second change has to do with fingerprinting. This has actually already been done in section §846-2.7 to allow the Board to do fingerprinting. The last change would be NURSYS. These three changes would be the last of the changes that need to be done to have the Hawaii Board of Nursing come into full compliance with the Model Act.

Ms. Yokouchi stated she is not here to shove all this down your throat; she is here to be a part of you and to ask for the Boards consideration. Ms. Yokouchi wanted to share all this with the Board early and hope that they can work together and present a unified front. We do have the ear of the legislature right now. They do understand the need for nurses and they know nursing itself has progressed tremendously in terms of education, training and practice.

Ms. Stone Murai stated her concern is with the licensing issue. She is not sure she agrees that is wouldn't take some changes to things because the Board here regulates the basic programs we don't do much with the graduate programs so it seems appropriate to license based on that. We do have a statement in our rules that says the APRNs scope of practice subsumes the RN practice, so it could be argued that it's covered perhaps under that statement. However, since we do license based on NCCLEX we do have authority over the basic programs. There might be a need to look at that particular aspect of things.

Ms. Yokouchi stated, you do have statutory authority to approve graduate programs. It's in the laws under education. You don't have an exam for APRNs but you do have jurisdiction over that.

Ms. Stone Murai stated we do require national certification. Although it's not a licensing exam it is an exam. Ms. Stone Murai stated her other concern was what happens when an APRN advances in their career and decides that they don't want to practice clinically but want to share their expertise doing administrative work or other work and they can't for a variety of reason keep up their APRN. How do they revert back to their RN license.

Ms. Yokouchi stated if you review the four areas of APRN, those are regulated because they are clinical. It does not mean that those who are in education and/or administration are not in advanced nursing, but it's because of the hands on aspect of these four areas that the boards of nursing get involved.

Ms. Stone Murai asked, are you looking for two different licenses or are you looking for one. Therefore there needs to be a mechanism in place that if you step out of the clinical arena but they are licensed as an APRN, how do they fall back on their RN license.

Ms. Yokouchi stated they can still use their titles they earned. Whatever titles they earned through education, they are entitled to use that, it says it in your laws. When is comes to the APRN, the only reason why this Board has any jurisdiction over them is because they have hands on contact with patients.

Ms. Stone Murai stated it will be very confusing if people are using titles and they don't have the license or recognition.

Dr. Fleming asked, aside from aligning us with the consensus model, what are the other benefits of being licensed versus recognition.

Ms. Yokouchi stated a lot of new Board members don't understand the purpose of the NCSBN. Back in the 80's and 90's when nursing was coming up in the medical field a lot of lay people and policy makers said when you look a the state boards they all have different standards for education, practice and licensure. The national council, all of them got together and tried to do this standard. This is the whole purpose for all of these things, so when they go before congress, when they plead for medicare benefits, to get reimbursements, they can say this is nursing. We can say we have standard education, standard scope of practice and therefore we are professional. The bottom line is uniformity.

Mr. Hoban asked when these types of things go forward, what would be the opposition to something like this from other areas.

Mr. Yokouchi stated none. The physicians know that there is such a huge shortage, and that APRNs are the next group to move in.

Mr. Joslyn asked Ms. Yokouchi to summarize the proposed amendments regarding NURSYS.

Ms. Yokouchi stated a majority of states, except Hawaii and a few others have joined NURSYS, which is a data bank where employers can find out if a nurse has had any disciplinary action, criminal history, etc. They do work with federal guidelines so it's not something where if we give this information to them it will go out into the world. The particular language provided to the Board is from Missouri. A person from the Missouri Board came here with the NURSYS representative from the NCSBN to explain what NURSYS was about and the person from the Missouri Board provided the EO with this language that allowed Missouri to adopt NURSYS. Ms. Yokouchi stated she spoke with Maryann Alexander who does the NCSBN regulatory part of it and she said the states don't really have language that says they adopt NURSYS, but they have enabling language that allows the state board to share information through NURSYS with other state boards.

The EO stated it is a data bank. If we share this information with NURSYS, which is considered confidential, we can do a public search but we can also do a member search. It will tell us if an applicant has had disciplinary action in other states. When someone applies for licensure in Hawaii we ask for the NURSYS report, cause like Ms. Yokouchi said a majority of the states are giving their data to them. When we get the report, some individuals will have twenty states that they are licensed in. So instead of getting verification from twenty states we get it all on one report from NURSYS. It cost the applicant \$30, but it would cost the applicant more if they had to go to each individual state to get verification. Basically it would benefit us. The reason we have to put this language in and not just participate is because Hawaii has privacy laws regarding your information. It would benefit us tremendously. We get tons of verification requests everyday, one person does it, besides from doing other things. Going back to recognition versus license, like Ms. Yokouchi says it's semantics. We issue a separate license to you anyway, whether you call it a license, registration, recognition, certification, it's semantics.

If we want to be in line with the APRN consensus model and change it to license, all we do is change it wherever is says APRN recognition, change the word to license. It's not going to change the requirements, its not going to affect the APRNs practice in any way. To EO stated regarding the criminal history check, she recalls reading about a federal requirement coming down that if you work in a Medicaid or medicare facility you are going to be required to do a criminal history check. We actually already have something in place to do the search. We have a mechanism in place to do the search, we have access. Just putting this language in here and changing the law would allow us to ask all applicants to get a criminal background check and we would be able to pull it from this data base.

Ms. Elvenia asked if fingerprinting is part of the NURSYS report. She stated she had to do one for the state and it cost her \$80.

The EO stated she does not know how much it would cost.

Ms. Yokouchi stated to consider the fact that your main role is consumer safety.

Mr. Hoban stated he is a little confused because he sees there is cost for the NURSYS, then another cost for the fingerprinting, and obviously we're looking at ways to lower our overall cost of providing medical care, at the same time we're requiring employers to spend X amount of dollars just to hire someone. Who pays for NURSYS and the fingerprinting.

The EO stated it will be the applicants' responsibility to order and pay for it.

Ms. Yokouchi stated ultimately the goal is to have a driver's license mode. So if you are bringing in nurses or if you are nurse going out to another state, if you are licensed in Hawaii you did your NURSYS and your fingerprinting, you're done for the rest of the nation. It does require that the legislature or the governor sign it into terms of a compact.

Mr. Hoban stated now you are going into a compact state situation.

Ms. Yokouchi stated ultimately it's to make it quick for every state to have immediate information on nurses.

Mr. Hoban stated its gets cloudy as to what employers are mandated to do. Meaning as an employer you have to have records to prove that a nurse has gotten NURSYS, has gotten fingerprints done. It can get muddy as to the employers requirement and what they have to pay for. Mr. Hoban stated he understands what the EO is saying that the applicant has to pay for it but that's not always conducive to getting new employees.

The EO stated those would be strictly license requirements. What the employer does afterwards would be up to them.

Ms. Elvenia asked would it be only a first time requirement, or annual. The EO stated right now it would only be for initial licensure.

Ms. Tali stated right now many states are requiring fingerprinting before you're even eligible to test.

Ms. Yokouchi thanked the Board for their time.

Correspondence

The Board reviewed an article about healthcare reforms and how people will receive medical care in the months and years ahead.

Ethics Advisory 2013-03

The Board reviewed a memorandum from the Hawaii State Ethics Commission on the issue of a Board member applying for a position selected, hired or otherwise subject to approval by the Board.

<u>Prescriptive privileges to APRN-CNMs that do not possess a Masters degree</u> The Board reviewed an email inquiry regarding APRNs that do not possess a masters degree prescribing.

The Chair Pro Tem stated prescribing authority has always been tied to a masters degree from day one. Previously in the wild west days before things were as regulated, people would do things like put a blank prescription pad in their associated physician's mailbox and get it back signed the next day.

Guest Pat Jewell was present and addressed the Board. Ms. Jewell stated before the wild west, what happened before the masters degree prescriptive privileges laws went into affect, some states required that you had a signed protocol filed with the state board of nursing. Before you required APRNs to have a masters degree to have prescriptive privileges, was anything set up with the Board of Nursing. If not, where did that leave nurses and the patients that they cared for. Ms. Jewell stated she addressed the Board before and got a response back saying its up to your protocols of policies and procedures

of where you work. Ms. Jewell stated she needed something more concrete from the Board. There is a lot of nurses out there that don't have masters but are certified and have privileges as an APRN. Can there be a set of protocols with back up MDs at each facility or can something be filed with the Board of Nursing that allows nurses under the MD to call in a prescription.

Dr. Fleming stated it would be the MDs prescription not the nurses.

Ms. Jewell stated yes, she just needs something concrete from the Board saying if I have a back up MD.

Dr. Fleming interrupted saying it would not be a back up MD, the MD is the prescriber.

Ms. Jewell stated yes.

Guest Dr. Chang stated if she is the prescribing MD, even if she is not physically present in the office at that time, as long as I say its ok, cause right now at Kalihi Palama they're saying the nurse has to find someone who is physically present in the clinic.

Dr. Fleming stated then that is the clinics policy.

Dr. Chang stated what they want to know is it against the Board of Nursing.

Dr. Fleming stated it is not against the law to take a verbal order.

The Chair Pro Tem stated verbal orders do need to be signed.

Dr. Chang stated yes, correct but can Ms. Jewell call in a prescription saying its under Dr. Chang.

Dr. Fleming stated yes, anyone can.

The EO stated basically you are acting as the prescribers authorized agent. If you look under Chapter 328, which is the Department of Health, Food and Drug Branch, they have jurisdiction over physician dispensing and prescribing. I believe it is mentioned in 328 about the prescribers authorized agent which you, as the nurse would be. The nurse does not have prescriptive authority; the MD does, so you would be acting as the prescribers agent.

The Chair Pro Tem stated any APRN who does not meet the requirements to have prescriptive authority is functioning under the RN scope.

Ms. Jewell and Dr. Chang thanked the Board for their time.

Scope of Practice Question

The Board reviewed an email inquiry regarding questions that will be asked over the telephone by nurses (who may or may not be registered in Hawaii) and non-professionals. The data gathered is submitted for assessment and follow up to a nurse who is licensed in the state where the patient resides.

	The EO stated if they are just asking questions and gathering information, is that considered the practice of nursing.
	Ms. Elevnia stated the questions look like an assessment.
	Mr. Hoban asked are these considered professional comment, in other words the answers that they give to these questions are they considered professional answers.
	Dr. Fleming stated no. It appears someone wants a para-professional in their office to gather all of the patients' histories. The reality is sometimes you will go into a doctors office and they will ask the patient to fill out a questionnaire. So it certainly does not require that you be a nurse to ask the questions.
	The Chair Pro Tem stated the first question states that they are looking to help determine the program benefits that best fit your needs. The concern was about telehealth, which is in 457-2, it states telehealth means the use of electronic information and telecommunication technologies to support long distance clinical healthcare, patient and health professional, health related education, and public health and health administration, to the extent that it relates to nursing.
	After further discussion it is the Board's informal interpretation that asking questions do not constitute the practice of nursing. This is an informal interpretation only, not binding on the Board, for informational and explanatory purposes only.
