Approval of the Minutes: The Chair called for a motion in regards to the minutes of the August 11, 2011 meeting.

Ms. Stone Murai recommended the following amendments:

Page 1, under "Approval of the Minutes", the first line should read, "Ms. Stone Murai stated that the response to the inquiry regarding RN's initiating bolusing and maintaining the PC pump following epidural placement appears to be vague and that explains why these inquiries keep coming back to the Board."

Page 9, under "Question on Nurse Licensure Compact, Jillian Yasutake, Department of Labor and Industrial Relations", the second paragraph should read, "After some discussion, they agree that adopting the NLC would allow out-of-state nurses to come to Hawaii and Hawaii nurses to practice in other compact states more easily. However, there are other factors to consider that may require more studies, including but not limited to, determining the fiscal impact on the Board, Hawaii nursing programs and their graduates, State facilities that utilize nurses, etc. and the impact on the nursing workforce."

The DAG recommended the following amendment:

Page 6, under "Nursing Jobs in Hawaii, Nancy Warner", the second line should read, "Their [sic] are little to no jobs available...".

Also, on page 6, under Nurse Practitioner Scope of Practice Question, Michael J. Palazzo, delete the quote before the sentence, "I need clarification on whether or not...".

There being no further amendments to the minutes, upon a motion by the Vice Chair, seconded by Ms. Cohen, it was voted on and unanimously carried to approve the minutes of the August 11, 2011 meeting as amended.

The Chair called for a motion in regards to the executive session minutes of the August 11, 2011 meeting.

Ms. Stone Murai recommended that on page 2, the first line should read, "The Vice Chair also commented that any registered nurse, doctor, or physician assistant can delegate to administer medication."

Fall 2011 Member Board Review of Newly Developed Items and/or Simulated Examinations, October 12-31, 2011 – Deferred from the August 11, 2011 meeting for more information.

Information regarding this meeting was distributed to the members for their information.

Education Committee
Report:

Ms. Cohen reported that at the August 11, 2011 meeting, the committee discussed the following:

Annual Reports

Ms. Cohen reported that the annual report notice, revised annual report and the G-4 reports were sent to all the Board approved nursing programs. Because of the new annual report, the Committee agreed to extend the deadline for submission of the annual reports to October 1, 2011.

Quarterly Reports

Kauai Community College

The quarterly report submitted for the Fall 2011 Faculty Clinical Assignments was deferred for clarification and additional information.

University of Phoenix

The quarterly report submitted for the period covering April - June 2011 was accepted, however, their request to be released from the requirement to submit quarterly reports was deferred because there was insufficient information.

Next Meeting

Ms. Cohen stated that the Education Committee will be meeting after today's Board meeting.

Upon a motion by Ms. Cohen, seconded by the Vice Chair, it was voted on and unanimously carried to accept the report and recommendations of the Education Committee.

Practice Committee Report:

Ms. Stone Murai reported on the Practice Committee meeting this morning prior the Board meeting:

APRN-Rxs Prescribing Controlled Substances – Status Report

Ms. Stone Murai reported that the EO received another email from the DEA and that they had referred the information to their Chief Counsel. She stated that the EO would be emailing the DEA periodically to check on the status.

She also reported that the Department of Public Safety, Narcotics Enforcement Division was processing Hawaii APRN-Rxs who applied for oral codes and to register to prescribe controlled substances.

Proposed Amendments to HAR Chapter 89

Ms. Stone Murai reported that the Committee is still reviewing proposed amendments to HAR, Title 16, Chapter 89 to align the administrative rules with the current law, more specifically Act 110, SLH 2011 and past Acts and also discussed the possibility of "collapsing" the APRN-Rx license into the APRN license. She explained that by "collapsing" the separate APRN-Rx license and making the prescriptive authority a privilege that the APRN will still have to apply for but no separate APRN-Rx license will be issued that will also eliminate the license and other fees normally assessed for a separate license. She reported that once the Committee accepts a final draft, it will be presented to the Board for consideration/discussion.

Joint Formulary Advisory Committee ("JFAC") & Exclusionary Formulary for APRN-Rxs

Ms. Stone Murai reported that the JFAC held their meeting on August 24, 2011 and that they reviewed the previous formularies, including the amended draft prepared by the Practice Committee using the 2004 formulary. The next JFAC meeting is to be announced.

Next Meeting

Ms. Stone Murai reported that the next Practice Committee meeting is scheduled for October 6, 2011, before the Board meeting.

Upon a motion by Ms. Stone Murai, seconded by the Vice Chair, it was voted on and unanimously carried to accept the report of the Practice Committee's September 1, 2011 report.

Correspondence:

Request for Recognition by the Wound, Ostomy Continence Nursing Certification Board as a Nurse Practitioner Specialty, Anne Jinbo – Request Board Reconsider Their August 11, 2011 Decision

The Board reviewed Ms. Jinbo's request for the Board to consider recognizing wound, ostomy, and continence nursing as a specialty since they have a separate certification that certifies nurses in the different areas as well as foot care.

Ms. Jinbo was present and addressed the Board, referring to the APRN application that indicates "national certification" and to update the Board in regards to their certification.

The Chair informed Ms. Jinbo that there is no wound, ostomy and continence APRN specialty. However, an individual who qualifies as a family nurse practitioner ("FNP") could obtain national certification in wound, ostomy, and continence but not without the FNP.

Ms. Jinbo referred to the APRN application referring to current certification in the nursing specialty from a national certifying body recognized by the Board or approved by the American Board of Nursing Specialties.

Ms. Stone Murai referred Ms. Jinbo to the NCSBN APRN model graphic which illustrates that licensure, and therefore the Board's responsibility, occurs at the levels of Role and Population foci versus specialty certification which is the responsibility of the specialty certifying organization. The Wound, Ostomy, and Continence Nursing Certification Board's website lists completion of a Graduate level NP or CNS program as a prerequisite for application as an advanced practice nurse in this specialty.

After further discussion, Ms. Jinbo stated that she understood.

Ms. Stone Murai stated that the Board will review the APRN application to determine if it should be amended for clarity.

PBN August 5, 2011 Article "Doctor shortage getting worse; hospitals finding ways to cope"

A copy of the article was distributed to the members for their information.

The article reports that Hawaii has a shortage of 669 doctors and that the number is expected to increase to more than 1,600 by 2020. The article also refers to a nationwide trend that is relying more on advanced practice registered nurses to alleviate the physician shortage. The article stated that advanced nurse practitioners have the authority to fill prescriptions, which is not true since APRNs with prescriptive authority cannot dispense any prescription drugs.

NCSBN and the Form of State Nursing Workforce Centers – Collection of Nursing Workforce Data from States in 2012

A copy of the notice was distributed to the Board members for their information.

The EO stated that she sees a potential problem if they ask the Board for contact information for nurses so that they can retrieve the data. The Board may not be able to accommodate their request due to privacy provisions in the uniform information practices act.

Call Numbers (Oral Codes) for APRN-Rx -- Ashley Rivera

The Board received an email inquiry from Ms. Ashley Rivera who is asking for information on how to get a call number when she calls in a prescription to an outside pharmacy.

Members instructed the EO to inform Ms. Rivera to call the Department of Public Safety, Narcotics Enforcement Division for this inquiry.

The Vice Chair asked the EO if information can be posted on the Board's website under Important Announcements. The EO informed members she will draft something up and send to the Practice Committee for their comments.

Child and Adolescent Scope of Practice and DEA Licenses – Michael J. Palazzo and Wailua Brandman

The Board received an email inquiry from Mr. Michael Palazzo and Mr. Wailua Brandman regarding APRN-Rx controlled substances. Based on the email, Mr. Palazzo is requesting the Board to provide assistance on how to become a licensed APRN-Rx who can prescribe controlled substances.

After discussion, the Board instructed the EO to inform Mr. Palazzo that the application to prescribe controlled substances is on the Board's website and to call the Drug Enforcement Agency for this inquiry.

Questions Regarding Dermatological Adult Clinical Nurse Practice (ACNS)-- Connie Bridgman

The Board received an email inquiry from Ms. Constance Bridgman regarding autonomously performing in a physician's office various dermatology practices such as skin biopsys, juvederm injections, dermal fillers, sclerotherapy, IPL (laser) treatments, etc.

After discussion, the Board responded to Ms. Bridgman's questions as follows:

1. Can I practice autonomously in dermatology with the same authority as an NP?

Answer: Refer to HAR §16-89-1 about the appropriateness of/permission to implement specific procedures in particular work settings and a recommendation to seek legal counsel on this.

2. Can I bill and be reimbursed in dermatology practice with the same authority as an NP?

Answer: The Board does not have any authority for billing/reimbursement issues and cannot provide an opinion.

The Board refers you to HAR §16-89-81(4), for the clinical nurse specialist scope of practice.

Core Competencies and Scope of Practice for Psychiatric Nurses -- Lori Allard

The Board received an email inquiry from Ms. Lori Allard regarding core competencies and scope of practice for psychiatric nurses.

After discussion, the Board responded to Ms. Allard's questions as follows:

1. The core competencies for psychiatric nurses?

Answer: RN licenses are not issued by specialty, only the APRN license is. The RN scope of practice is defined in HRS Chapter 457. Ms. Allard can find further information on the website of the professional and certifying organizations for this specialty.

2. Scope of practice for RN?

Answer: Same answer as above.

3. Scope of practice for psychiatric nurses?

Answer: Same answer as above.

RN's Following MD Protocols for Administering Injections -- Sherry Endresen

The Board received an email inquiry from Ms. Sherry Endresen asking for clarification on RNs following MD protocols for administering injections once the physician has diagnosed the condition and ordered the treatment with injectables. Can the RN treat the patient when the physician is not on the premises with those standing orders for specific patients?

After discussion, the Vice Chair stated that Ms. Endresen should refer to HAR §16-89-126, Scope of nursing practice, and HAR §16-89-128, Standards of care.

RN's Dispensing Telephonic Medical Advice to Hawaii Residents -- Lisa Shroer

The Board received an email inquiry from Ms. Lisa Shroer asking if RN's dispensing telephonic medical advice to Hawaii residents need to be licensed in Hawaii?

After discussion, the Board determined that, based solely on the information provided, a Hawaii RN license is required for dispensing telephonic medical advice to a Hawaii resident.

LPN and RN Completing Medication Refill Requests for Primary Care Provider -- Pat Thompson

The Board received an email inquiry from Ms. Patricia Thompson, who is a doctoral student at St. Louis University and is asking whether it is legal for a medical assistant, LPN, and/or an RN to complete medication refill requests for a primary care provider, whether it be a physician assistant, physician, or nurse practitioner.

After discussion, the Board referred Ms. Thompson to HAR §16-89-100, Delegation of tasks of nursing care to unlicensed assistive personnel. Also, the Board deferred decision making on the medical assistant as they are not licensed under the Board of Nursing.

Telephonic Nurse Case Management Services to Residents of this State -- Christine LaCoy

The Board received an email inquiry from Ms. Christine LaCoy asking if a license is required to provide telephonic nurse case management for workers' compensation claims. They will not be meeting with any of the injured workers only talking with them telephonically to assist them in recovery.

After discussion, the Board determined that, based solely on the information provided a Hawaii RN license is required for telephonic nurse case management to a Hawaii resident.

Pre-employment physicals by nurse practitioners -- Margaret Maupin and Jere Graham

A copy of the email was distributed to the members for their information.

The Board received an email from Ms. Margaret Maupin and Ms. Jere Graham expressing their frustration by having their signatures rejected by The Point, a timeshare company, for pre-employment physical exams.

Nurse delegation to an Educational Assistant, Terry Bruesehoff

The Board reviewed Ms. Terry Bruesehoff's request for information on nurse delegation to an educational assistant. Ms. Bruesehoff asks the Board: "If this unlicensed personnel is working directly with an RN but is an employee of the DOE, who is legally responsible for her? She doesn't work for Nursefinders, yet will be performing licensed activities, i.e. cough assist machine, etc.....Who is doing her competencies, her supervisory visits, skills checklist, etc?" "Will it be their Nursefinders license if something happens to this student when they crash? If Nursefinders agree to take this case, aren't they taking on this responsibility since the educational assistant is working directly with them and they would be giving that educational assistant direction?"

The Board determined that, based solely on the information provided, the Board has no jurisdiction in this matter since the Board does not "regulate" or have jurisdiction over the administration of medications by "unlicensed personnel" in the school setting.

Filing complaints with the State Ombudsman's Office, Christi Keliipio

Ms. Christi Keliipio emailed the Board to welcome the nurses to the Hawai'i State Ombudsman's website. The Ombudsman's office independently and impartially investigates complaints against state and county agencies and employees.
