Approval of the Minutes: The Chair called for a motion for the May 3, 2012 meeting minutes.

Dr. Mukai stated that on page 2 under "Review of Annual Pass Rate for Hawaii Nursing" **Programs**" it appears that the Committee is recommending the Board adopt a new annual pass rate when the Board has consistently determined that the annual pass rate for Hawaii nursing programs should not be below 90% of the national annual pass rate.

Ms. Fleming recommended that the following amendment be made to clarify that the Committee is not recommending anything new: "...it was the consensus of the Committee members to recommend to the Board to incorporate into a new rule the Board's policy that the annual pass rate for Hawaii nursing programs should not be below 90% of the national annual pass rate,...".

<u>Hawaii Nursing</u> Schools/Programs:

Annual Report Form

The Committee continued their discussion on amendments to the annual report form. After some discussion, it was the consensus of the Committee to make the following amendments to the annual report form:

- Page 2, under "Retention Rates:", amend to read as follows: "Retention Rates:
 Indicate the number of students who stay in the program. Please indicate how
 you determine your retention rate. The Committee agreed that the retention rate
 for each nursing program may vary depending on the period used for calculating
 the retention rate and decided to have the individual nursing programs explain
 how they determined their retention rate.
- Page 2, Retention Rate chart, delete period "7/1/20__-6/30/20__" for both current and past year and replace with "Specify dates", for same reasons listed above.
- Page 3, should read "Please explain any program retention rate below 80 percent."
- Page 3, under "Examination: NCLEX Pass Rate" the explanation should read, "Based on the attached G-4 report (Jurisdiction Program Summary of All First Time Candidates Educated in Jurisdiction of Licensure) for the period from July 1, ____ through June 30, ___. IF the pass rate is below 90% of the national average, as determined by the National Council of State Boards of Nursing, please indicate the following:".
- Page 4, under the declaration for "All Newly Appointed Faculty Declaration:" change the word "verified" to "verify".
- Page 4, under the declaration for "Continuing Nursing Faculty Competency Declaration:", it should read, "I have reviewed all continuing nursing faculty and verify that they have met all the requirements of Hawaii Administrative Rules section 16-89-45.
