Executive Officer's 2012 Legislature Report

Report:

The EO reported on the following legislative bills:

Senate Bill No. 2103, SD2, HD2, CD1 - Relating to Health

This bill, which amends the definitions of "the practice of nursing as a licensed practical nurse" and "the practice of nursing as a registered nurse" to require licensed practical nurses and registered nurses to carry out the orders of a physician that are delivered through a physician assistant acting as an agent of the supervising physician, was enrolled to the Governor on May 8, 2012.

<u>House Bill No. 2023 – Relating to the Center for Nursing</u> A copy of Act 53, SLH 2012 was distributed to the Board members for their information.

Senate Concurrent Resolution No. 53, SD2 – Requesting Collaboration Among Various Agencies to Identify and Remove Barriers Relating to Workforce Data Sharing and Nursing Practice in the State

The EO reported that the concurrent resolution crossed over to the House but was not scheduled for hearing.

Report on Continuing Education Joint Advisory Committee

The EO reported that the next scheduled meeting for the Committee is scheduled for June 8, 2012.

Request from the Board of Pharmacy

The EO reported that the Board of Pharmacy appointed their representatives at their May 31, 2012 meeting so the next step is to schedule the joint meeting of the representatives from both the Board of Nursing and the Board of Pharmacy.

After some discussion, it was the consensus of the Board to inform the Board of Pharmacy that the joint meeting is tentatively scheduled for August 2, 2012, subject to confirmation by the Chair and Ms. Stone Murai of their availability.
