The Executive Officer distributed the following results of the Private Detectives' and Guards' examination:

Chief Perry provided questions relating to the pertinent HRS, Chapters for the examination and the package was forwarded to the Examination Branch Chief. Chair Mack and Chief Yabuta were advised that multiple choice questions should be developed.

Scope: a. State of Hawaii – Department of Human Resources Development, Inquiry Relating to the Impact of Act 208

Members discussed Ms. Lisa Hodges' e-mail and inquiry regarding the impact of Act 208 (SLH 2010) ("Act 208") on the Division of Conservation and Resources Enforcement

("DOCARE") which is located within the Department of Land and Natural Resources.

The Board reviewed the excerpts from Chapter 199, HRS, relating to the Conservation and Resources Enforcement Program, the duties and powers of Conservation and Resources Enforcement officers, and the minimum qualification specification for the Conservation and Resources Enforcement Officer series.

After careful consideration and based solely on the information provided to date, it was moved by Chief Yabuta, seconded by Mr. Souza and unanimously determined that although the Conservation and Resources Enforcement Officers are acting in a guard capacity under HRS chapter 463, they are "law enforcement officers" under HRS sections 710-1000 and 712A-1 (for purposes of HRS section 463-1's definition of a "guard"). In addition, the Board determined that the DOCARE is a "law enforcement agency". Accordingly, Conservation and Resources Enforcement Officers and other employees of DOCARE are <u>not</u> required to comply with the new guard registration and training requirements imposed by Act 208 or HRS chapter 463.

New Business:

a. New Employee Registration Form

The Executive Officer informed members that the new semiannual employee registration form is on the Board's website at www.hawaii.gov/dcca/pvl, and reported that the form is now fillable. This should ease the burden for employers.

. Subcommittee Report

The Executive Officer informed members that Chair Mack and Mr. Denis met with Ms. Preshess Willets-Vaquilar from Honolulu Community College ("HCC") to discuss the educational requirements in Act 208. Ms. Willets-Vaquilar informed them that she would have to speak with her superior to determine the feasibility of HCC not only providing the educational course, but being the coordinator through which all entities providing the course must funnel and to be sole issuer of certificates. The Executive Officer will keep the Board apprised after the meeting.

Chair Mack discussed the following options discussed with Ms. Willets-Vaquilar:

- 1. <u>HCC Program which allows employers or other</u> third party trainers:
- a. Develop course outline using Board criteria.
- b. Train the trainer (binder, course, power point CD, exam, etc.).
- c. Offer security officer training.
- d. Receive attendee data, issue certificate, send updates of electronic file to DCCA.
- 2. <u>Board Program</u>:
- a. Companies submit training course and instructors to Board for review and approval.
- b. Numerous providers certificates from all those approved.
- c. Numerous training programs out there no consistency or standard.
- d. Insufficient DCCA staff to handle applications and training provider approval.
- 3. <u>Board using outside providers:</u>
- a. Develop RFP, contract, etc. to have provider develop course, issue certificates.
- b. Professional Security Training Network ("PSTN") to develop, review and certify information.
- c. Employers able to do in house training using PSTN or other vendor to insure standard training/course.
- 4. <u>HCC to conduct all training and create exams for training modules:</u>
- a. While employers may negotiate contract classes with HCC, HCC is the sole provider of the initial training and continuing education.
- b. HCC may be unable to handle demand.
- c. HCC only issuer of certificates.

The Board deferred this issue until the Sub Committee can discuss these options.
