Executive Officer Taniguchi stated an election for Vice-Chairperson would be taken up at this time, and requested for nominations. Chairperson Conboy nominated Mr. Cool for the position of Vice-Chairperson; there were no other nominations. It was moved by Chairperson Conboy, seconded by Mr. Stellmacher, and unanimously carried to elect Mr. Cool as the Committee's Vice-Chairperson.

Unfinished Business:

None.

Appraisal Subcommittee:

Ms. Klamet gave a brief description of the Appraisal Subcommittee ("ASC") which oversees the appraisal regulatory programs established by States. Ms. Klamet provided the following results/comments from this Program's seventh bi-annual field review for compliance with Title XI of the Financial Institutions Reform, Recovery, and Enforcement Act:

 Statute/Rules: the language in the rules should be amended to take out education credit for challenge exams; to remove qualifying education for teaching; and as well as to clean up the definitions.

- Temporary License Applications: license needs to be issued within five (5) business days; no backdating of appraisal dates; effective date should match approval date; inconsistent use of the National Registry in verifying a licensee's status; and a suggestion of a six (6) month duration to complete the appraisal.
- Disciplinary action needs to be recorded in a timely manner to the National Registry.
- Application was revised from their last field review Ms. Klamet commented that the current application and checklist "looks great". Again reminded to use the National Registry in verifying a licensee's status on an endorsement application.
- Course Provider Agreement: courses reviewed were qualified and relevant – no concerns.
- Enforcement: Ms. Klamet stated that they were awaiting for more details from the Regulated Industries Complaints Office who handles complaints but did note that there were fourteen (14) new complaints and eight (8) outstanding complaints - six (6) of those outstanding complaints were over a year old. She also noted that they reexamine complaint files from the previous field review, and noted that three (3) of those ten (10) cases were destroyed.

Ms. Klamet stated that a preliminary report from ASC would be sent to the Department of Commerce and Consumer Affairs ("Department"), for their response within sixty (60) days with a plan to correct/address concerns found from their field review. Subsequently a report will be made by ASC with both the preliminary report and the Department's response.
