#### Real Estate Education Advisory Council

#### Real Estate Education Specialist Report

The Education Committee met on February 13 and selected Larry E. Wofford as the next Real Estate Chairholder.

Edwin Shiroma moved and Toru Kawakami seconded to approve Dr. Larry Wofford as our next Real Estate Chairholder. Motion carried unanimously.

#### New Bulletin

Dr. Richard Haney will write an article on "Equal Credit Opportunity Act" in the Commission's quarterly news bulletin.

#### Request of Cathi Watson

Sandy Holck reported that the Education Committee reviewed the film on "Mathematical Skills". He recommended that it does not justify the use of money from the real estate education fund and that the licensees won't directly benefit from it.

Joseph Blanco moved and Toru Kawakami seconded to accept the recommendation of the real estate education specialist. Motion carried unanimously.

#### OCP Handbook

Through Sandy Holck, OCP requested monetary contribution from the real estate education fund to reprint "Landlord-Tenant Code" handbook.

This matter was deferred to the March meeting.

### Amendment to Real Estate Education Specialist Contract

After discussion, Toru Kawakami moved and Edwin Shiroma seconded to amend the real

estate education specialist contract by additional \$6,000 subject to approval of justification. This additional fund will be expended to hire a consultant to help draft the Commission's rules. Motion carried unanimously.

#### Monitoring of Neighbor Island Schools

After a lengthy discussion, Edwin Shiroma moved and John Urner seconded to allow real estate education specialist to monitor the neighbor island schools at least one and check on the schools. He will submit a written report to the Commission. Motion carried unanimously.

#### Real Estate Chair

#### Funding for Year 1982

Acting Dean David Bess was present to request Commission's approval for funding of the Chair for 1982.

Chairman Morris assured that the Chair will be funded for 1982 however requested that College of Business Administration provide the Commission with the proposed program for the Chair during this time frame.

- 3. Darryl Choy, hearings officer, is still working on the declaratory ruling on Nanea Apartments (CON-DR-81-1). This matter will be ready for the March meeting.
- 4. Inasmuch as Yukio Higuchi, Executive Secretary, is still on medical leave, Executive Secretary George Arine was requested to check on the status of the proposed amendments. Is it necessary to hire a consultant to complete the rules what needs to be done.
