Call to Order:

The meeting was called to order by Chairman G. A. "Red" Morris at 9:20 a.m.

The Executive Secretary apprised the Commission that the agenda for today's meeting was duly filed on Monday, March 23, 1981 at the Lt. Governor's office in compliance with the Sunshine Law.

Minutes:

Edwin Shiroma moved and Tadayoshi Ishizu seconded to approve the minutes of January 30, 1981 as circulated. Motion carried unanimously.

The minutes of February 27, 1981 was deferred as it was not prepared in time.

Committee Reports:

Real Estate Education Advisory Council

Application for Real Estate Instructor Certification and School Accreditation

Joseph A. Tanega (s)

As recommended, Edwin Shiroma moved and Ralph Yagi seconded to waive the 6-month experience and approve application of Joseph Tanega for certification as a real estate salesman instructor subject to receipt of his DOE licensure. Motion carried unanimously.

Tanega Institute of Realty

Edwin Shiroma moved and Ralph Yagi seconded to grant the Real Estate Education Specialist authority to approve the application of this school subject to meeting the satisfactory classroom sessions. Motion carried unanimously.

Accreditation of Real Estate Schools

Sandy Holck reported that he talked with Mr. Okaji, Licensing Administrator, regarding the accreditation of real estate schools. Mr. Okaji indicated that the Commission can suspend Rule 4.5 which requires a real estate school to be certified by the DOE before given approval by the Real Estate Commission.

The Real Estate Commission will be the sole body or agency to approve the real estate school operation.

Chairman suggested that we get something in writing from the administrator to this effect.

Upon motion by Edwin Shiroma, seconded by Tadayoshi Ishizu and unanimously carried, the Real Estate Commission will be the accreditation agency on a temporary basis. Real Estate Education Specialist was directed to alert the real estate schools regarding this matter.

21 Classroom Sessions

Real Estate Education Specialist checked with Mr. Kagehiro of DOE on this matter.

The questions posed were:

1. Does a class session mean a period of instruction in which a particular subject of a real estate course is conducted?

"A class session means a period of instruction during any given day and/or night in which a particular course leading to a specific vocation is conducted The length of instruction provided during such day and/or night may vary."

2. If so, can two or more subjects of a real estate course be conducted in a day?

"Course instruction on any given day/night may include more than one subject/topic or sessions."

DOE will submit a memo to the Commission informing the real estate schools that a class session may not be held on a different day and that more than one class session can be held during a particular day or night.

Visit to California Department of Real Estate

Sandy Holck requested and received approval for Joseph Blanco and himself to stop over for 1 day in Sacramento, California, on their way back from the ETS meeting in Princeton, New Jersey, to check the real estate education system and research center.
