Morris called the meeting to order at 9:20 a.m.

Minutes: Upon motion by Edwin Shiroma and seconded by

Ralph Yagi, the Commission unanimously approved

Hearings: RE-LIC-83-5 Jason Matayoshi

Edwin Shiroma moved and Ralph Yagi seconded to accept the Hearings Officer's recommended order to deny Jason Matayoshi's application for license.

Motion carried unanimously.

RE-LIC-83-6 Dayle W. Carlson

After a lengthy discussion, Joseph Blanco moved and Ralph Yagi seconded to reman the case back to the Hearings Officer to obtain additional evidence. Motion carried unanimously.

RE-81-38 and RE-81-39 Kenny Aihara

Following discussion, Edwin Shiroma moved and Ralph Yagi seconded that based on Hearings Officer's recommended order that he be required to pay a \$500 fine within 60 days of the Commission's final order. If not paid within 60 days, Aihara's license will be revoked. If it is paid, his license will be suspended immediately for a period of one year and at the end of the suspension period, on reinstating his license, he will be required to take the Commission's recommended course. Motion carried unanimously.

CON-82-12 Ind-Comm Management

Randy Iwase, Deputy Attorney General, explained the terms of the settlement agreement. The purpose of the settlement is to address those disclosures which they believe to be compelled by §514A-85, H.R.S.

Joseph Blanco moved and Edwin Shiroma seconded to accept the settlement agreement of the Attorney General's office. Motion carried unanimously.

Real Estate Education Report

Cindy Alm reported on the activities of Dr. Wooten who is here to conduct the feasibility study on establishment of a research center in Hawaii. Dr. Wooten will report his findings to the Education Committee on Wednesday, May 11, 1983.

Constance Smales moved and Joseph Blanco seconded to approve expenditures for neighbor island travel including Yukio Takeya for the May meetings. Motion carried unanimously.

ETS Cut Score Study and Item Writing

Cindy Alm reported that Joe Malone from ETS and a panel consisting of industry people participated in the cut score review study and item writing on April 21-23, 1983.

Education Chairman Joseph Blanco commended Cindy Alm for doing a tremendous job in getting the group together on very short notice.

Joseph Blanco moved and Edwin Shiroma seconded to approve payment for half of the expenditures - air fare, honorariums and lunches. Motion carried unanimously.

- 6. Compensation for Foreign Brokers to do research with other states how they have handled splitting fees with foreign brokers
