# Hearings Officers' Reports

1. RE-82-130 Helen Deangelo, Thomas Atwill Professional Rental Management Corporation (Recommended Decision as to Respondent Helen Deangelo

The Commission reviewed the Hearings Officer's proposed Settlement Agreement as to Respondent Helen Deangelo.

Upon motion by Commissioner Sodetani, seconded by Commissioner Smales, the Commission unanimously amended the proposed Settlement Agreement and requested that the Respondent be required to take the complete RECCAL course in addition to paying the fine of \$500 within thirty days of the final order.

Upon motion by Commissioner Takeya, seconded by Commissioner Sodetani, the Commission unanimously adopted Hearings Officer's findings and conclusions that Respondent Atwill's real estate broker's license be suspended for one year and that he pay a fine of \$1,000 within 60 days of the final order. If Atwill fails to pay within the allotted time, his broker's license will be suspended for a period of two years and his relicensure to be contingent upon his paying the fine.

Respondents Tom Schmidt Realtors B-l and Thomas F. Schmidt to pay the restitutions and fine plus interest no later than January 2, 1985. No extension shall be granted. If full payment is not made on time, there will be an automatic revocation of Respondents' licenses and as a condition to reinstatement, all fines with interest must be made. Motion carried unanimously.
