Committee Reports: Education Committee

Commissioner Blanco, Chairman of the Education Committee, reported on the following:

Licensing Exam REP's

The staff is working on the services and pricing. Commissioner Smales moved and Commissioner Sodetani seconded to approve a maximum of \$1,000 in expenditures, if necessary, for consulting services regarding psychometric of the exam. Motion carried.

U.H. Foundation

Upon motion by Commissioner Blanco, seconded by Commissioner Sodetani, the Commission unanimously approved to grant \$12,000 to the U.H. Foundation, Real Estate Fund to purchase equipment to facilitate work for the real estate program.

ETS Exam Wuestion Review Session

The exam review session will be held on February 4 and 5, 1985 with eight individuals reviewing the exam. They will be paid \$50 by ETS.

Following discussion, Commission voted to approve additional honorarium of \$50.00 per day per person from the education fund. The motion was made by Commissioner Sodetani, seconded by Commissioner Smales and unanimously carried.

Status of Residential Property Transfer Code

The Residential Property Transfer Code Report has been approved by the Commission and forwarded to the Legislature.

The Commission is to review the code, revise the curriculum and reflect it in the salesman and broker courses.

Chairman Morris requested that the Education Officer be responsible for developing this package revising the curriculum, to be reviewed by the Education Committee and the Commission and sending it out to the real estate schools for discussion for purpose that these items will be used for exams.

Commissioner Smales moved and Commissioner Damron seconded to approve the Education Committee minutes of January 8, 1985 and ratified all actions taken therein. Motion carried unanimously.

Real Estate Research and Education Center

The Commission had discussion on submitting the final revised copy of the Real Estate Research and Education center report to Dean David Bess and Chancellor Kosaki.

Upon motion by Commissioner Damron, seconded by Commissioner Sodetani, Commission unanimously adopted the study, as amended, to be put in its final form to be forwarded to Dean Bess for submittal to Chancellor Kosaki with the report on "A Review of Real Estate Commission Regulatory and Educational Functions (1984)."
