Hearings Officer's 1. RE

Report:

1. REC-LIC-85-16 Esther L. Glenn

The Hearings Officer reviewed the findings of facts, conclusions of law, and recommended order in the Glenn case.

Upon motion by Commissioner Takeya and seconded by Commissioner Yanagawa, the Commission unanimously accepted Hearings Officer's recommendation to deny Esther Glenn's real estate application.

2. RE-84-120 Bette L. Ward

Commissioner Blanco moved, and Commissioner Takeya seconded, to accept the settlement agreement. Respondent was fined \$500, with \$400 suspended, payable within 30 days from the date of final order. Motion carried unanaimously.

3. RE-85-47 Betty J. Ho

Upon motion by Commissioner Blanco, seconded by Commissioner Damron, the Commission unanimously approved the settlement agreement which orders respondent to pay a fine of \$250 within 30 days from the Commission's final order.

4. RE-84-89 Harold M. Ouchi
