Minutes of Meeting of March 20, 1987

Approval of Minutes:

The minutes of the February 26, 1987 Public Hearing and the February 27, 1987 Commission Meeting were distributed to the members for their review prior to the meeting.

Upon a motion by Commissioner Sodetani, second by Commissioner Damron, the Commission unanimously approved the minutes of the February 26, 1987 Public Hearing and the February 27, 1987 Commission Meeting as circulated.

The motion was voted on and unanimously carried.

Additions to Agenda:

Restoration - Over 2 years

Commissioner Blanco moved to add the applications listed above to the agenda. Commissioner Matsuo seconded the motion. The motion was voted and unanimously carried.

Hearings Officer's Reports:

IRA GORDON, RE-84-229 - Oral Argument on State Motion for Reconsideration

Ira Gordon and his attorney, Ralph LaFountaine were present to present Oral Arguments. Richard Marshall, RICO Attorney, was present to present oral arguments on behalf of the State.

Mr. Marshall requested a motion for reconsideration based on the amount of evidence in support of the violation of Section 16-33-3(c), which is the failure to ascertain and disclose pertinent facts.
Mr. Marshall stated that the findings of fact proved that the respondent committed a violation in not getting the dual representation in writing. Mr. Marshall cited a recent settlement agreement in the matter of Catherine Aiu, where the respondent failed to inform clients of dual representation in writing.

Mr. Marshall also informed the Commission of an article written up in the Hawaii Legal Reporter which stated that the Commission had dismissed charges against a real estate agent who had failed to obtain a written consent from both parties before representing them. Mr. Marshall also stated that if the Commission felt that the sanctions were too excessive in the circumstances where all parties were informed of the dual representation, he suggested finding a violation but imposing little or no sanctions.

Mr. Ralph LaFountaine represented the respondent, Mr. Gordon. Mr. LaFountaine stated that their position was and is that there was no dual representation. He also stated that he was not aware of the Catherine Aiu case.

Commissioner Damron asked Mr. Marshall if a licensee could represent a purchaser in one transaction and at another time represent that person as a buyer. Mr. Marshall responded that there should be no problems with brokers or salespersons in different capacities in separate transactions as long as the transactions are not interrelated.

Commissioner Sodetani asked Mr. Marshall if the settlement agreements approved by the Commission sets a precedent. Mr. Marshall stated that while not as persuasive as a decision, it is assumed that the Commission reviewed the agreement and approved it. The Hearings Officer, Lea Crandall, later clarified the difference between a settlement agreement and a final order. She stated that precedent is set by cases that go to a hearing where the facts are discussed and the law is stated. Past settlement agreements are used as a basis for determining sanctions but they do not set a precedent.

Chairman Morris asked if Mr. Gordon had represented himself as an investment counselor and if it was stated on his business card. Ms. Crandall produced an exhibit of Mr. Gordon's business card which stated, "Investment Counselor."

Commissioner Damron moved to deny the motion for reconsideration. Commissioner Sodetani seconded the motion. The motion was voted on and carried. Chairman Morris opposed the motion.

THOMAS M. LUNSFORD, RE 86-163 SETTLEMENT AGREEMENT

Commissioner Sodetani moved to accept the settlement agreement of a \$1,500 fine, with \$1,000 suspended if the balance of the restitution is made within 30 days. Commissioner Blanco seconded the motion. The motion was voted and unanimously carried.

EDUCATION COMMITTEE

Upon a motion by Commissioner Blanco, second by Commissioner Sodetani, it was voted and unanimously carried to accept the following recommendations of the March 11 and 19, 1987 Education Committee Meetings as circulated:

- 1. Approve that staff reconcile its internal record keeping of the Education Fund income and expenses with DCCA's fiscal records as of December 31, 1986; authorize Commissioner Yanagawa to be responsible for monitoring and coordinating the Commission's internal education fund accounting with the DCCA's fiscal department records and to retain the necessary professionals towards these ends.
- 2. Approve in concept a visual presentation campaign (including video, advertisements, brochures, public service announcements) for education on the agency issue and that the Education Committee Chairman is authorized to select, retain and expend up to \$50,000 of the education fund for the services of a media or public relations firm to coordinate the visual presentation.

- 3. Approve the amendment to Dr. Robert Allen's existing contract relating to the formation of the Commission's Five Year Plan, include compensation for additional services for a written report to the Commission, relating to the findings of the curriculum committee, in the amount up to \$2,500 at \$30.00/hour.
- 4. Approve payment of a daily \$50.00 honorarium or subsidy to each licensing exam item writer for the April 8, 9, and 10 writing session.
- 5. Approve increased funding request from the Research Center for additional contract research and research materials in the amount of \$10,706.38. The amount is subject to the Center providing the Commission with written information on the Center's itemized expenses and budget.
- 6. Approve not publishing the schools' passing rates until such time as ETS institutes a different procedure for encoding school codes on the answer sheet.

Commissioner Damron moved to require the Real Estate Research and Education Center to submit their program of work and budget by June 15, 1987 for consideration at the annual symposium. Commissioner Sodetani seconded the motion. The motion was voted on and unanimously carried.

LAWS AND RULES REVIEW COMMITTEE

Upon a motion by Commissioner Takeya, second by Commissioner Smales, it was voted and unanimously carried to accept the following recommendations of the March 19, 1987 Laws and Rules Review Committee Meeting as follows:

1. Approve Commissioner Blanco's developing a specific proposal and meeting with the media companies to solicit bids to coordinate dissemination of information on the new agency law and rules.
