HOCKING VS. DUBOIS

Mr. Bodden reported on the ongoing case of Hocking vs. DuBois which basically argues that if an condominium is sold in a

condominium project which has a rental pool, the buyers are subject to the Federal Securities Laws. Every apartment in the condominium project becomes a security.

Commissioner Blanco requested that Mr. Bodden submit a brief on the above mentioned case to the Commission. He also suggested that a summation of the case appear in the Real Estate Bulletin.

Commissioner Yanagawa requested that this issue be placed on the agenda of the next Laws and Rules Review Committee meeting.

Mr. Bodden will send a copy of the documents relating to the court case to the Commission.
