In the Matter of the Real Estate Salesperson's License of Thomas E. Caprio, REC 98-122-L

Upon a motion by Commissioner Ching, seconded by Commissioner Evangelista, it was voted on and unanimously carried to reject the Settlement Agreement Prior to Filing of Petition for Disciplinary Action and Commission's Final Order.

In the Matter of the Real Estate Salesperson's License of Steven H. Burke, REC 98-16-L

Upon a motion by Commissioner Nomura, seconded by Commissioner Ching, it was voted on and unanimously carried to accept the Settlement Agreement After Filing of Petition for Disciplinary Action and Commission's Final Order.

The Commissioners asked the Special Deputy Attorney General to convey to RICO its recommendation that standard language be included in the settlement agreements that if the Respondent is a real estate salesperson or a broker/salesperson, they must notify their principal broker of the disciplinary action and if the Respondent is a principal broker, they must notify the licensees under their direction of the disciplinary action.

Following the Commission's review, deliberation and decisions in these matters, pursuant to Chapter 91, HRS, the Chair announced that the Commission was reconvening its scheduled Commission meeting at 10:10 a.m.

Edward A. Neizman

Richard M. Shively

Shively's application for a real estate salesperson's license. Commissioner Imanaka seconded the motion. The motion was voted on and unanimously carried.

Malia L. Jackson

After a review of the information submitted by the applicant, Commissioner Ohama moved to approve the real estate salesperson's license of Malia L. Jackson. Commissioner Evangelista seconded the motion. The motion was voted on and unanimously carried.

Henry W. Quayle

After a review of the information presented by the applicant, Commissioner Ching moved to deny Henry W. Quayle's application for a real estate salesperson's license, based on §467-8(3), HRS and §436B-19(1), (8), (12), and (14), HRS. The Commission determined that the criminal conviction is directly related to the qualifications, functions and duties of the license profession, and that the nature of real estate activity is such that real estate licensees frequently have access to persons, residences, personal and private information, and are frequently alone with clients and members of the general public. Further, the Commission determined that Mr. Quayle had not provided sufficient evidence of rehabilitation to warrant the public trust, as provided for in §831-3.1, HRS. Commissioner Ohama seconded the motion. The motion was voted on and unanimously carried.
