Call to Order: The Chair called the meeting to order at 9:00 a.m., at which time quorum was

established.

Chair's Report: The Chair announced that the Commission may move into executive session to

consider and evaluate personal information relating to individuals applying for licensure in accordance with Section 92-5(a)(1), HRS, and/or to consult with the Commission's attorney on questions and issues pertaining to the Commission's powers, duties, privileges, immunities, and liabilities in accordance with Section

92-5(a)(4), HRS.

Commissioner Abrams was excused from the meeting. Prior notification of his non-attendance was received.

The Supervising Executive Officer informed the Commissioners that the original applications with any original associated documents to be considered at the meeting were available for review.

Minutes of Previous Meeting

Upon a motion by Commissioner Suiso, seconded by Commissioner Gendrano, it was voted on and unanimously carried to accept the minutes of the March 27, 2009 meeting.

Committees and Program of Work:

Condominium Review Committee – Performance Bonds/Irrevocable Letters of Credit – Requests for Release

Deputy AG Wong reported that she researched legislative history going back to 1977 and did not find anything significant that spoke towards performance bonds and statute of limitations on performance bonds.

Senior Specialist Yee stated that she spoke with the Time Share Administrator, it is their practice to accept an architect's statement requiring a mechanic's lien endorsement, and they will release the bond. She noted that time share projects are most closely related to condominium projects.

The Commissioners discussed the statute of limitations, expiration dates of bonds and the fact that each bond is different.

Commissioner Chee arrives.

Absent compelling evidence, it was the Commissioners inclination to not cancel the bonds and releases should be examined on a case-to-case basis.

After discussion, the Commissioners agreed to continue to review any pending and future requests to release Performance Bonds/Irrevocable Letters of Credit on a case-to-case basis. Also, in the rulemaking process, move towards uniformity of Performance Bonds/Irrevocable Letters of Credit and update the Condominium Consultant's checklist.

Licensing – Ratification:

Upon a motion by Commissioner Aiona, seconded by Commissioner Ball, it was voted on and unanimously carried to ratify the attached list.

Chapter 91, HRS, Adjudicatory Matters: The Chair called for a recess from the meeting at 9:17 a.m., to discuss and deliberate on the following adjudicatory matters, pursuant to Chapter 91, HRS:

In the Matter of the Real Estate Broker's Licenses of Phillip G. Kuchler, Inc., dba Kuchler and Company, and Phillip G. Kuchler, REC 2002-116-L and REC 2003-109-L

Commissioner Kuriyama moved to accept the Third Amended Settlement Agreement After Filing of Petition for Disciplinary Action and Commission's Final Order. Commissioner Chee seconded the motion. Commissioners Aiona, Ball, Chee, Gendrano, Kuriyama, Nishihara and Suiso voted aye. Commissioner Loudermilk voted nay. The motion carried.
