Law and Rules Review Committee

Hawaii Association of REALTORS® draft bill relating to continuing education

The Hawaii Association of REALTORS[®], draft bill relating to continuing education was distributed to the Commissioners for review. Discussion to take place at the January 13, 2010, Laws and Rules Review Committee meeting.

Licensing – Ratification:

Upon a motion by Commissioner Kuriyama, seconded by Commissioner Loudermilk, it was voted on and unanimously carried to ratify the attached list.

Licensing – Applications:

The Supervising Executive Officer informed the Commissioners that the information provided to the Commissioners is related only to the issue that is before the Commission for consideration. The other materials submitted are available for the Commissioners review should they desire to review it. If the applicants have an issue, which is personal in nature, they have the right to request that their application be considered in executive session.

Ermelinda M. Pascua

Ms. Pascua appeared via teleconference. Ms. Pascua was asked if she wished to have her application for real estate salesperson's license considered in executive session. She declined the offer.

Ms. Pascua stated that she submitted a statement explaining that she tried to obtain documents from the courts and has been unsuccessful. She has contacted the legal department and they were unable to provide her any documentation and was not able to write a letter on her behalf. She added that the only document that could be produced was the court calendar.

Ms. Pascua explained that her conviction relates to a parking ticket and safety check violation, for which she paid the fines; however, a bench warrant was issued and she was charged with contempt of court. She stated that the case has been resolved, but the incident remains on her record.
