Upon a motion by Commissioner Ball, seconded by Commissioner Loudermilk, it was voted on and unanimously carried to approve the minutes of the March 28, 2008 meeting.

Committees and Program of Work:

Education Review Committee - CE Administration, Curriculum, Courses, Providers and Instructors

Course – "The REALTOR Code of Ethics in 2008;" Author/Owner: Jim Hogan and Curtis Hall; Provider: Hogan School of Real Estate, Inc.; Course Category: Other – Ethics and Professional Development; Clock Hours: 3

Commissioner Ball said that she had reviewed the course and the provider has incorporated the changes recommended by the Education Review Committee.

Upon a motion by Commissioner Ball, seconded by Commissioner Loudermilk, it was voted on and unanimously carried to approve "The REALTOR Code of Ethics" as a three clock hour continuing education elective course under the course category of Other – Ethics and Professional Development.
