Hawaiian Island Commercial, Ltd.

Garret Tom was asked if he wished to have this application considered in executive session. He declined the offer.

Garret Tom, Principal Broker of Hawaiian Island Commercial, Ltd., was present to answer any questions and did not have any further information to add.
