Upon a motion by Commissioner Abrams, seconded by Commissioner Loudermilk, it was voted on and unanimously carried to accept the minutes of the May 25, 2007 meeting.

Committee Reports & Program of Work:

#### **ARELLO Annual Conference**

Upon a motion by Commissioner Abrams, seconded by Commissioner Ball, it was voted on and unanimously carried to approve sending up to four participants to the ARELLO Annual Meeting, to be held on September 14 to 17, 2007, in New York City, New York, subject to budget and DCCA approval. The REC Chair and the SEO will determine the participants.

# Hawaii Association of REALTORS Request for Quotations (RFQ) Proposal Submitted

Senior Real Estate Specialist Fujimura reported that an RFQ was posted on the State's HePS system to provide two Instructor Development Workshops ("IDW") and one real-estate related seminar over a two-year period. The Hawaii Association of REALTORS ("HAR") was the only vendor to submit a proposal. HAR is proposing to submit one IDW in late summer/fall of this year and another one in 2008. The seminar would be held in 2008.
