Education Review Committee

Upon a motion by Commissioner Ball, seconded by Commissioner Abrams, it was voted on and unanimously carried to accept the report of the October 10, 2006 Education Review Committee meeting as follows:

- 2. Prelicensing Education Administration, Curriculum, Schools, Instructors, and Equivalency Administrative Issues

Recommend approval that the Instructors Exam re-examination requirement every three years be eliminated. Prelicense instructors will no longer be required to take the Instructors Exam every three years after initial certification is obtained.

Recommend approval that the Instructors Development Workshop requirement for instructors each biennium be retained. The IDW for teaching the core course is beneficial, and helps give structure and guidance to the instructors teaching the core course.

The EO informed the Commissioners that the information provided to the the Commissioners is related only to the issue that is before the Commission for consideration. The other materials submitted are available for the Commissioners review should they desire to review it. If the applicants have an issue which is personal in nature, they have the right to request that their application be considered in executive session.

Matthew H. Ngo

Matthew H. Ngo was asked if he wished to have his application for a real estate salesperson's license considered in executive session. He declined the offer.

Upon a motion by Commissioner Abrams, seconded by Commissioner Ball, it was voted on and unanimously carried to take this matter under advisement.

William D. Craighead

William D. Craighead was asked if he wished to have his request to remove the conditions from his real estate salesperson's license discussed in executive session. He declined the offer.

Mr. Craighead said that he had applied to work for Fairfield Resorts and he went through the interview and testing process. Two weeks before classes started, he gave them the letter regarding his conditional license. On the third day of class, he was told that the broker would not hire him. The owners of Activities for Less did not want to hire him. Activities for Less had an opening for an OPC. He was told he could take that position and they would see how he performed. Fairfield Resorts decided not to hire him.

Mr. Craighead said that he has a long history in the business community. He was proactive in the seafood industry and his sales and the number of employees that he had increased. He was active in a fishery group and was elected as Vice President for a few years. He was appointed to an advisory committee and involved in the International Conference of Atlantic Tunas, which included 29 countries.

He decided to make a career change. Mr. Craighead said that he will not give up on pursuing a real estate career, but he would like to have the conditions removed. Mr. Craighead stated that he has been active in the community, is politically active and is active in the industry.

Mr. Craighead thanked the Commissioners for allowing him to present his position.

Mr. Craighead was questioned as to why Fairfield Resorts changed their mind in hiring him. Mr. Craighead said that Fairfield Resorts was buying Activities for Less as of January 1, 2007. He went to the corporate office in Las Vegas and they told him they would not hire him. He did not apply any where else for a position. He was afraid to apply at other places for the same reasons. Mr. Craighead said that he would be good for the industry. He said that he needs to stop paying for his transgressions that occurred in 2001. He needs to get it behind him. He is 55 years old and cannot continue paying for his mistakes any longer.

Upon a motion by Commissioner Abrams, seconded by Commissioner Chee, it was voted on and unanimously carried to take this matter under advisement.
